## **RESOLUTION NO. 2 OF 2023**

BY THE CADDO PARISH COMMISSION:

A PROCLAMATION (RESOLUTION) ORDERING AND CALLING A SPECIAL ELECTION TO BE HELD TO FILL THE VACANCY IN THE OFFICE OF CADDO PARISH COMMISSIONER, DISTRICT 8, FOR THE UNEXPIRED TERM THEREOF; TO SET THE DATE THEREFOR AND OTHER PERTINENT MATTERS, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, a vacancy exists in the office of Caddo Parish Commissioner, District 8, due to the resignation of the Honorable Jim Taliaferro on December 30<sup>th</sup>, 2022 and

WHEREAS, the unexpired term of said office exceeds twelve months; and

WHEREAS, the Caddo Parish Commission, as the governing authority of the Parish of Caddo, is therefore required to call an election to fill the unexpired term of said office by Caddo Parish Charter, Section 3-04.

NOW, THEREFORE, BE IT RESOLVED by the Caddo Parish Commission in due, regular and legal session convened, as follows:

Section 1. That, as required by and pursuant to law, an election shall be and the same is hereby called to elect a successor to the office of Caddo Parish Commissioner, District 8 to serve the unexpired term of the vacant office.

Section 2. That, in accordance with La. R.S. 18:602 and 18:402, the primary election to elect a successor to the unexpired term shall be held on October 14, 2023, and the general election, should it be necessary, shall be held on November 18, 2023; both elections to be held within the boundaries of Caddo Parish Commission District 8, Parish of Caddo, State of Louisiana, between the hours of seven (7:00) o'clock a.m. and eight (8:00) o'clock p.m. in compliance with the provisions of the Louisiana Election Code.

Section 3. That the Clerk of the Caddo Parish Commission shall publish this resolution immediately in the official journal of the Parish of Caddo.

Section 4. That the polling places for Commissioners and the polling places for this election shall be the same as those designated and approved as polling places within Caddo Parish Commission Districts 8 in accordance with the provisions of the Louisiana Election Code.

Section 5. That the qualifying period for the primary election shall open at 8:30 a.m. on August 8, 2022, and shall close at 4:30 p.m. on August 10, 2022.

Section 6. In accordance with Title 18, Section 426 of the Revised Statutes of Louisiana the number of commissioners serving at each precinct is hereby reduced to the minimum number authorized by law.

Section 7. That the Clerk of the Caddo Parish Commission be and he is hereby empowered, authorized and directed to execute and furnish any certification, form, proclamation, or ancillary requirement for the proper holding of said election.

Section 8. That the Clerk of the Caddo Parish Commission shall forward certified copies of this Resolution by certified mail within twenty-four (24) hours to the Louisiana Secretary of State and the Caddo Parish Clerk of Court, in accordance with La. R.S. 18:602.

BE IT FURTHER RESOLVED that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that this resolution shall take effect immediately upon its adoption.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict herewith are hereby repealed.

In accordance with La. R.S. 18:653, I am enclosing a copy of the notice of resignation received on December 27, 2022 by our office from the Honorable "Jim" Taliaferro as Parish Commission Member, District 8, Parish of Caddo, with an effective date of December 30, 2022.

Pursuant to La. R.S. 18:583, an anticipated vacancy has occurred in the above-specified office. The governing authority shall therefore within twenty (20) days call a special election in accordance with the Caddo Parish Home Rule Charter and La. R.S. 18:602 (on or before January 16, 2023). The next available election is the fall 2023 gubernatorial election currently scheduled for October 14, 2023 and November 18, 2023, with qualifying dates of August 8, 9, & 10, 2023.

Additionally, pursuant to the Caddo Parish Home Rule Charter, La. R.S. 18:583(D)(1), and La. R.S. 18:602, the governing authority shall within twenty (20) days of the office actually becoming vacant (after December 30, 2022, but before or on January 19, 2023) make an appointment to fill the office.

After a proclamation is issued calling the election and an appointment has been made, a certified copy of the proclamation calling the special election as well as the certified minutes of the meeting in which the appointment was made or certified resolution, should be mailed to our office. A commission will be issued to the person appointed to fill the vacancy.

If the governing authority does not timely call the special election and/or make an appointment, we will forward a request to the Governor to do so pursuant to La. R.S. 18:602.
