## MINUTES OF THE SPECIAL SESSION OF THE CADDO PARISH COMMISSION HELD ON THE 12<sup>th</sup> DAY OF JANUARY, 2023

The Caddo Parish Commission met in a Regular Session, on the above date, at 4:35 p.m., in the Government Chambers, with Mr. Burrell, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Burrell, Chavez, Epperson, Gage-Watts, Hopkins, Jackson, Johnson, Jones, Lazarus, and Young (11). ## **NEW BUSINESS**

It was **moved by Mr. Jones,** seconded by Mr. Epperson, that Resolution No. 2 of 2023, a proclamation (resolution) ordering and calling a special election to be held to fill the vacancy in the office of Caddo Parish Commissioner, District 8, for the unexpired term thereof; to set the date therefor and other pertinent matters, and to otherwise provide with respect thereto (Fall Election)

Mr. Jackson and Mr. Hopkins addressed concerns regarding the published agenda.

It was **moved by Mr. Jackson,** seconded by Mrs. Gage-Watts, *to recess for five minutes.* Motion carried by acclamation.

It was **moved by Mr. Young**, seconded by Mrs. Gage-Watts, *to reconvene into session.* Motion carried by acclamation.

It was **moved by Mr. Epperson**, seconded by Mrs. Gage-Watts, *to close nominations*. <u>Motion carried</u>, as shown by the following roll call votes: AYES: Commissioners Burrell, Chavez, Epperson, Gage-Watts, Hopkins, Jackson, Johnson, Jones, and Lazarus (9). NAYS: Commissioners Atkins, and Young (2). ABSENT: None (0). ABSTAIN: None (0).
