### **RESOLUTION NO. 35 of 2023**

BY THE CADDO PARISH COMMISSION:

RESOLUTION TO SUPPORT AN ECONOMIC DEVELOPMENT INITIATIVE AT THE SHREVEPORT BUSINESS PARK, AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, Project Pronto is an economic development project that will be located Shreveport Business Park, where the GM Plant was formerly located, and;

WHEREAS, the project will bring a publicly traded, Forbes Global 500 company to Caddo Parish, and;

WHEREAS, that company will bring approximately 596 jobs to Caddo Parish at an average salary of sixty-thousand dollars plus benefits, and;

WHEREAS, Caddo Parish will support this initiative with economic incentives commensurate with the company's job provision and commensurate with the capital investment requirements put forth by the State of Louisiana.

NOW, THEREFORE, BE IT RESOLVED by the Caddo Parish Commission in due, regular and legal session convened, that the Caddo Parish Commission does hereby recognize and support the location of Project Pronto at Shreveport Business Park.

BE IT FURTHER RESOLVED if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.
