<p>On Thursday, March 14, 2024 at approximately 6:03 p.m. I arrived at 4028 Mayfield Street in reference to a bite. Upon arrival I made contact with a black male that stated the grey pit bull currently chained at 4027 Mayfield Street was the bite dog and was at large when the bite occurred. He stated the victim was his girlfriends 2 year old son and they were gone in an ambulance to LSU.</p> <p>CSO Deputy Jackson arrived on scene and advised she and her husband were the owners of the bite dog, King. She advised she believes the dog is up to date on its Rabies Vaccination but wasn't for sure and didn't know what vet her husband usually takes the dog to. She advised her husband is Terrance Jackson and he will contact CPAS with the vaccination information.</p> <p>I captured and secured the bite dog in my service unit. I impounded the dog at CPAS. I scanned the dog for a microchip, no chip was detected.</p> <p>I cleared the scene and proceeded to LSU Hospital to make contact with the bite victim. I arrived at LSU Hospital at 6:40 p.m. and made contact with Shambre Watson, who stated her son Xiare Watson is the victim. Shambre stated she left her son in the care of her boyfriend while she walked to the store and when she returned she was made aware that the bite had occurred and EMS were already enroute. She stated she did not have any other information about how the bite occurred.</p> <p>I cleared the scene. Bowers</p>

<p>On Friday 03/15/2024 at approximately 12:45 p.m. I arrived at 4027 Mayfield St in reference to delivering a CPAS Dangerous Dog Classification Notice.</p> <p>Upon arrival, I made contact with Mr Terrence Jackson who I advised that the CPAS Director has determined that his dog shall be deemed dangerous. He understood. When asked about the incident, he stated that a neighbor told him that Mr Dilly Mazyck was walking his dog "King" down to Kelly Key St. He stated that Mr Mazyck then went back to 4027 Mayfield St to chain the dog back up. While chaining the dog back up, Mr Mazyck child wandered over to the address and was bitten. I advised him that there are still several violations that he faces. The dog is improperly enclosed and not rabies vaccinated. He understood. When asked if he agrees with the director's determination or disagrees and wants to proceed with a dangerous dog board, he stated that he would like to proceed with the board. Mr Jackson then signed both the CPAS Dangerous Dog Classification Notification and Classification Information. A copy of the dangerous dog ordinance was left with Mr Jackson. I explained a few of the stipulations of having a dangerous dog. I advised him that CPAS will follow up at a later date to hand deliver the date and time of the board. He understood. When asked what address would be the best to reach him at, he stated that he owns the houses at 4027 and 4023 Mayfield St, but now resides at 6115 Bradford Dr. No further action was taken.
