

ORDINANCE NO. 6433 OF 2024

BY THE CADDO PARISH COMMISSION:

AN ORDINANCE AMENDING THE BUDGET OF ESTIMATED REVENUES AND EXPENDITURES FOR THE RIVERBOAT FUND PROVIDE AN APPROPRIATION FOR PRIORITY, INTENTIONS, PRACTICAL EXCHANGES (PIPES), INC AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, Priority, Intentions, Practical Exchanges (PIPES), Inc. is a local non-profit organization with the mission of impacting the lives of local families and stakeholders by positively addressing challenges with resources and activities to prevent criminal behavior; and

WHEREAS, Priority, Intentions, Practical Exchanges (PIPES), Inc. advocates for criminal justice reform through letter-writing campaigns, prayer vigils, policy changes, and assists formerly incarcerated and incarcerated individuals with empowering programs to help reduce recidivism; and

WHEREAS, Priority, Intentions, Practical Exchanges (PIPES), Inc. has partnered with Children of God, Inc. to host the inaugural "Dinner With My Dad, An Evening of Celebrating Fatherhood" event on June 16, 2024; and

WHEREAS, this event addresses the launch of the Fatherhood Initiative, a national fatherhood family-focused initiative that aims to bring dads and youth together with the community to uplift through positive interactions.; and

WHEREAS, this crime prevention initiative event aims to decrease criminal activity through learning techniques, decreasing emotional and behavioral problems, and lowering juvenile incarceration; and

WHEREAS, this initiative provides an alternative to juvenile detention centers, break fatherlessness, decrease the prison pipeline, increase awareness, and teaches core values that help decrease drop-out rates, increase self-reflection and determination, while supporting father involvement, strengthening family ties, addressing poverty, economic stability, and contributing to society; and

WHEREAS, it is necessary to amend the Riverboat Fund to appropriate funds for Priority, Intentions, Practical Exchanges (PIPES); and

NOW, THEREFORE, BE IT ORDAINED, by the Caddo Parish Commission in due, legal and regular session convened, that Budget of Estimated Revenues and Expenditures for the Riverboat Fund for the year 2024 is hereby amended as follows:

BE IT FURTHER ORDAINED, that all ordinances or parts thereof in conflict herewith are hereby repealed.
