Mr. Jackson said that Providence House's budget was cut back during the NGO process.

Amendment by Mr. Johnson, seconded by Mrs. Gage-Watts, *that \$10,000 be moved from Tru Fund to Hope Connections.*

At this time, Mr. Johnson's amendment carried unanimously.

At this time, Mr. Jackson's amendment to include \$5,000 for Providence House carried unanimously.

At this time, the Clerk called the vote to adopt Ordinance No. 6377 as amended. It was **moved by Mr. Jackson**, seconded by Mr. Johnson, *that Ordinance No. 6377 of 2023 be adopted as amended.* Motion carried unanimously.

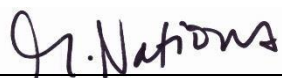
