

MINUTES OF THE WORK SESSION
OF THE CADDO PARISH COMMISSION
HELD ON THE 2nd DAY OF JUNE, 2025

The Caddo Parish Commission met in a Work Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mrs. Gage-Watts, President, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Blake, Burrell, Cothran, Epperson, Gage-Watts, Jones, Kracman, Lazarus, Thomas, and G. Young (11). ABSENT: Commissioner J. Young (1).

Mr. Jones gave the invocation, and Mr. Epperson led the Commission in the Pledge of Allegiance.

AGENDA ADDITIONS

It was **moved by Mrs. Gage-Watts**, seconded by Mr. Epperson, *that the agenda be expanded and Resolution of Remembrance for Pastor Cleonis Odom and Resolution of Remembrance for Pastor Danny Williams* be placed under New Business.

The President opened the floor for anyone to speak in favor or against this public hearing. There being no one to speak, the President closed the public hearing.

At this time, Mrs. Gage-Watts' motion be carried by all members who were present with Commissioner J. Young being absent (1).

CITIZENS COMMENTS

Sue Garcia came before the Commission and gave the following comment:

I do thank you for this opportunity to speak before you today. This is my first time to attend one of your meetings and I regret for having to say that for I have not done my duty to extent that I could have as instructed by God, to pray for those who are in leadership position over me and for that I ask your forgiveness. I'm her today to let you know that from this time forth I will be faithful to lift you up in prayer. You as well as our Mayor, our city council, and other elected officials. The job that you do is not easy, and I recognize that. When you make decisions that affect the population of this city, this parish, which includes the young, the old, the poor, the rich, the black, the white, the Hispanic, the Asian, it is a very heavy responsibility to wear a governmental mantle as you do. I too have come to learn that I also wear a governmental mantle. This mantle was not put on me through votes obtained through popularity and the democratic process. This mantle was put on me by the lord. He placed this mantle on me to be one who would pray for government leaders and to be one who would pray for the welfare of my city to see that it is protected and that the citizens therein prosper in every way. I'm here today to use my voce to share my heart as one who has lived in this city all my life. I have a great love for Shreveport. My husband raised our three children here. We have grandchildren who live here. I have worked as a registered nurse in your local area hospitals. I ended my nursing career teaching at the university laboring to educate the future red nurses of tomorrow. Having said that, I want to be quite honest with and say form a nurse's heart that I have great concern for the health of my city over the past few years. And I will say just retired just a few years ago. I was very busy in what I was doing, but God called me out of the nurse force way earlier than I even expected that I would be. Uh to he said, " You have cared for years for the temporal welfare of the body. I'm calling you to care for the eternal welfare of my body." Over the past few years, I have seen changes that have occurred that I believe have led to an instability that I believe can threaten the well-being and health of Shreveport and our surrounding community on Caddo parish. I've seen and heard things that have been of great concern to me. I regret that I have not made my voice. In my concern for our community, I'm here today to ask you in your role as commissioners to be diligent to protect out city through the ordinances you pass and the resolutions you speak forth. I ask you to consider those who will live under those ordinances and resolutions. I would ask first and foremost that you as our government leaders would consult god through prayer and to seek his counsel to determine if the legislation you seek to pass would please him and honor him or would it not? Would the legislation you pass benefit the citizens of this city and parish? Or would the legislation open a Pandora's box and call our city and our parish to be under God's judgment because it did not line up with his divine laws and ordinances? Doing what you do and the decisions you make can grave consequences. They can also have life-giving and life sustaining consequences, thank you for letting me speak today and once again please accept my apology that I have not prayed for you to the extent that I could have in past years. I will be praying for you in the days to come. On a closing note, I do want to tell you that I am the state co-leader for intercessors for America, which is national organization. If you have any specific prayer requests in the future, I would be happy to be of your service and to engage in prayer for you and those who you partner with through this prayer organization. Thank you very much.

Paige Hoffpower came before the Commission and gave the following comment:

All time and months are gods in Shreveport, Louisiana. We declare today that June is family month, not LGBT pride month. A call to uphold morality in our city. This petition today is made to the body of Christ, the city of council members, the Caddo commissioners presently trying to declare LGBTQ pride month in Shreveport, Louisiana this June 2025. This petition is made by the vast majority of families

and citizens in Shreveport Louisiana, who stand for God's biblical testimony of truth at all time is given and governed by him, the creator and sustainer of the universe. Therefore, June and all months are God's months and no time is rightly declared LGBTQ pride month because God is against sexual sin. But today our Caddo commissioners are developing a vote for the resolutions to be made again this year Which to my astonishment has been the case for the last several years declaring from their pulpit what God has not declared from his. We unite as one voice in Shreveport today as citizens who renounce all resolutions made by the city council and our Caddo commissioners that June is LGBTQ pride month and hereby declare June family month perpetually as righteous response to the breach that today is trying to and has been producing negative consequences ever since it was first declared. For marriage is given God's covenant of grace for man's well-being and the spiritual and sexual union of one-man Husband and one-woman wife which is ordained by God and established by him to produce offspring children to be raised up in families and fulfill his purposes in the earth. We remind our city officials of God's highest sovereign order and their duty to uphold his moral law and family structure which he instituted to safeguard our city remain under his moral blessing of protection instead of sin's rightful consequence of judgment. In addition to the word of God affirming God's sovereignty, all our American founding documents establish the Bill of Rights, the Declaration of Independence, we hereby reaffirm today the Louisiana State Constitution and preamble that we the people of Louisiana are grateful to almighty God for the civil, political, economic, and religious liberties we enjoy and desire to stay in his grace and blessings as city kept by God. We officially stand against the agenda items today referred to as 1112 that would continue to allow the abominable declaration over Shreveport, excuse me, declaration June LGBTQ pride month. We are also against the fruit of those resolutions which have increased the scope and the number of pride events taking place in our city today, promoting a sexually driven mission and resulting rise on entertainment for it. The resolution's false narrative of protection and equal rights has allowed a small fraction of our city's population to impose their sexual preferences and confusion on the broader community. Undermining the religious freedoms and moral conscience of the vast majority of true part of American citizens who stand in fear of God in honor of his word and in alignment with the Christian values and biblical institution of marriage and family that's foundational for a moral society. We strongly urge our governing authorities to stop the following LGBTQ pride events happening now in our city. Seeking to normalize an immoral sexual lifestyle in Shreveport, compromising the integrity of our city parks and institutions as well as the safety and innocence of our children, families, and communities. Number one, gay field day. This event openly promotes LGBTQ pride in our neighborhood parks, attempting to draw in the young and impressionable into a gay sex lifestyle. This has been going on for 5 years at Ac steer park. Such gatherings are falsely portrayed as harmless. Yet they cloak a lifestyle of serious sin against God and one's own body, leading to both natural and spiritual consequences and conviction, not shame or unjust treatment towards them by society. Which is how these resolutions falsely betrayed the LGBTQ pride need for a celebratory month in our city of open perversion, which has been used to increase sexually immoral entertainment, not equal rights. Number two queer pro. This event invites 16-year -old minors to attend an adult LGBTQ party where the gay sex lifestyle is celebrated as a focus. This predatory baiting of innocent minors and should be an illegal act of not if it is not already. Number three, drag shows. Over nine drag shows are promoted this 2025 as entertainment ways to celebrate LGBTQ pride in Shreveport. These events showcase men and women dressing up in clothes of the opposite sex and behaving provocatively. This sexual perversion of God's natural order and identity of men and women should not be promoted by city council and Caddo resolutions when in fact it is a high state of complete confusion. God's word condemns such acts in cities as demonstrated in the historical account of his judgement against Sodom and Gomorrah where the city's sexual sin brought the consequences of both cities' complete destruction. As highlighted above, our current trajectory God's divine moral law this matter and the warning found in it, which if not reversed will lead to lost generations, ultimate judgment of our city for the consequences of sin are spiritual, moral, and physical death. Before you today we acknowledge God as the supreme judge and authority over Shreveport. And we present his biblical word as fact the June and all months are God's months. And there is no time that is given to us by God that is not governed by his truth, holy spirit and divine moral law. Ans as a city we desire to live in the grace and bless in his grace and blessings. So, to restore righteous pride and dignity back to Shreveport families and the month of June we hereby declare by our own declaration as the body of Christ June family month perpetually in our city. This will begin to realign Shreveport with God's commandments, promises to heal, prosper, and protect us with the wall of family more firmly supported and in place as a protection against harm, temptations, and confusion targeting our children and the identity and their identity as children of God. Lastly, we caution all elected officials to act in alignment with the moral mandate bestowed on them by God and their constituents. To use the authority given to make righteous decisions that will morally prosper Shreveport, not bring us under judgement, aligning with God in his higher way for the families and citizens of Shreveport on this matter will be evidenced by a city council and county commissioner resolution declaring June family month.

Jon Glover came before the Commission and gave the following comment:

But more so what disturbs me is that we never discuss anything here at these work sessions hardly. You know, I thought a work session is the time for us to address the agenda items, the legislation that you are bringing before yourselves and us the public, giving us insight into what you all are proposing. Though you may have had committee meetings or whatever else, we the public don't always have access or don't attend those meetings. And that could be on us, but then it's too on you all too because you represent us. At the end of the day, it is incumbent that we give decision, give some attention to what we present in the chamber. You know, we say this is the people's chamber. Often times the people don't always believe that. It just depends on the circumstances and the situations. We are the people. You are the people as well. But you are the elected people that we have entrusted to do the bidding for ourselves,

but not with a blank check. So, when we rise to bring before you all and concern, we just ask that you listen to what we have to say. You don't have to respond because I know that is not the norm. But oftentimes we do get rebuttal, we don't need it if it's going to be in a derogatory manner. What we propose and what expect and what you expect from us is respect. That's it, give us the respect that you're asking us to give you. So, when you address these issues on your agenda, share the information with us. Don't have us deciding ore ourselves what this action item supposed to mean when you may have something totally different in your hearts and minds as to what you're supporting or even proposing. So, I ask again that our work session indeed begin to mirror a work session. Not that we're just going to advance what is brought before you all without even discussing it, and then it just makes the meetings longer on Thursdays. You have 18 resolutions on this agenda. And I tried to find information on at least 16 because two were just added here today. See I'm still in the dark. I don't know what you're proposing to me. And though those resolutions may identify persons or position or a mission, if you don't tell me what it is I don't know. So, you leave it to me to summarize for myself what that action will be regards to what your intent will be with regards to what your intent intends to be.

ADMINISTRATOR REPORT

- Juvenile Detention Census

Parish Administrator, Erica Bryant, said that there are 17 children in the Detention Center, five of which are OJJ. There are 452 children on probation. Twenty-six juveniles are at CCC.

- Caddo Correctional Center Census

Mrs. Bryant said that there are 1,493 inmates at CCC, with 1,158 being pre-trial detainees.

- Caddo Ready

Mrs. Bryant encouraged all to sign up with caddoready.org to receive weather and emergency alerts.

- Retirements

Mrs. Bryant announced that Chuck Wilson will be retiring on June 18, 2025; and Mr. Kevin Lawrence will be retiring in July of 2025. Mr. Atkins thanked Mr. Wilson and Mr. Lawrence for their service to the Parish.

COMMISSION REMARKS

- Mr. Epperson called upon the Christian community and the elected officials to call Job Corps.

- Mr. Cothran expressed concerns regarding the abrupt closure of the Shreveport Job Corps Center. He said that many students were left homeless due to the short notice. Requests were made for letters to be sent to federal representatives seeking answers and assistance.

- Mr. Jones said that Common Ground, a local non-profit food pantry, needs donations of peanut butter, canned proteins, and hearty soups. He said that this food pantry is vital to the community and encouraged all to help fill this need.

PRESIDENT'S REPORT

Mrs. Gage-Watts made a request for letters to be sent to federal representatives seeking answers and assistance regarding Job Corps.

She also congratulated the LSUS Pilots for their perfect season.

The Clerk of the Commission, Mr. Jeff Everson, brought forward Jacob, Nevin, and Finesse to introduce themselves. These individuals are the student workers in the Commission Clerk's Office.

Mrs. Gage-Watts ended her report with the following quote, "beware of any Christian movement that demands the government to be an instrument in God's wrath, but never a source of God's mercy, His generosity, or His compassion".

There was no Old Business, so the Commission moved onto New Business.

Mr. Atkins asked about the composition of the E. Edwards Jones Housing Trust Fund Technical Committee. Attorney Frazier explained that there was a recommendation to add two community members and a member of the Planning & Zoning Commission to this board.

He then made a **friendly amended** *to consider the Proclamation for Pride Month* be removed from the englobo. Mr. Thomas denied the friendly amendment.

Mr. G. Young requested that a summary of Ordinance No. 6548 of 2025, *an ordinance amending the Budget of Estimated Revenues & Expenditures for the Debt Service Fund and the Capital Outlay Fund to provide an appropriation of \$10,000,000 for the construction of a pickleball park, and to otherwise provide with respect thereto* be provided to the Commission.

Mr. Patrick Wesley came before the Commission and gave a presentation on the Pickleball Park developments. A proposal was made to build a pickleball park with nineteen courts, including a championship court. The project is estimated to cost approximately \$10M and would be managed by the YMCA. Revenues bonds would be used to finance the construction, with revenue generated from the facility covering the costs.

Mr. Atkins reiterated that the revenue from this project will pay for both the operating costs and financing costs. Mr. Wesley agreed.

Mr. Burrell wanted to know what would be considered a signature park. Mr. Wesley explained that they are the larger parks in the parks system. Mr. Burrell wanted to know if a more centrally located park would be more feasible. Mr. Wesley said that they are working with the school board, SporTran, etc. to develop pickleball from a grassroots effort.

Mr. Cothran said that he is struggling on a personal level to support a project of this magnitude right now. Mrs. Bryant mentioned that they are not asking the citizens for a tax to pay for this project; the revenues generated from the facility would pay for the project.

Mr. G. Young wanted to know if pickleball will become an Olympic sport. Mr. Wesley said that it will. He also mentioned that some states are making it a sanctioned sport with scholarships. Pickleball is here to stay, he said. Mr. G. Young continued by saying that he's been a champion of doing things inside the city limits, but the Commission should be more imaginative and dynamic when it comes to economic development.

Substitute motion by Mr. Atkins, seconded by Mr. Kracman, *that Special Resolution of Recognition Pride Month* be removed from the englobo. Motion carried, as shown by the following roll call votes: AYES: Commissioners Atkins, Blake, Epperson, Kracman, Lazarus, and G. Young (6). NAYS: Commissioners Burrell, Cothran, Gage-Watts, Jones, and Thomas (5). ABSENT: Commissioner J. Young (1). ABSTAIN: None (0).

At this time, Mr. Thomas' motion to englobo as amended carried by all Commission members who were in attendance with Commissioner J. Young being absent (1).

The Commission then moved onto Special Resolution of Recognition Pride Month.

Mr. Atkins: Thank you all for indulging our request to pull 11-11 from the englobo. It's not my objective to have a fight here—an argument here. You know, I wish we could focus more on the blocking and tackling of our activities and less on, you know, fighting about these things. But, I do see that this issue does cause some controversy; it does cause some concern; and for that reason, I'd rather not have it on our agenda. I just don't see the need to have it on the agenda. I'm sure that others feel differently, but I just wanted you all to know my thoughts. Thank you, Madam President.

Mr. Thomas: Thank you, Madam President. I did want to clarify the need for this to be on our agenda. There's an overwhelming amount of citizens here in Caddo Parish who do pay taxes, and who, more importantly, do vote. Not only that, as it's been expressed by your wonderful comments—if I was to say that I feel that women only 25 and under should have braids in their heads. That would exclude two people in this room right now. Once again, that's my opinion. I don't choose to dictate how you live your life. I don't choose to dictate your beliefs upon anyone else; I don't choose to admonish Muslims for not eating pork. It is not our job to put our beliefs upon others. I'm going to yield because I don't want to—I'll save that for Thursday, but I do feel it is important for us to—Thank you, Madam President.

Mr. Kracman: Yeah, I'd like to call for a vocal vote—a roll call vote.

President

Gage-Watts: What is your reason for a roll call vote? The machines are working great.

Mr. Kracman: Do I have to have a reason?

Mr. Thomas: You have to have a second.

President

Gage-Watts: There's nothing wrong with our equipment.

Mr. Kracman: Well, respectfully, I think its an incredibly contentious issue. I think putting our names on the screen isn't quite enough. I think saying it out loud is important.

President

Gage-Watts: Ok, that dies for the lack of a second. I'm sorry. Commissioner Cothran.

Mr. Cothran: Thank you, Madam President. You know, I really didn't want to get in this fight, but the thing is, at this particular time, you know, we've heard different feedback. We've heard from the public—those that are here. We heard Commissioner Jones. We've heard you, as well. The point being again—a resolution is a piece of paper. Ok? A resolution does not make anybody anything or do anything against anyone's personal beliefs. There's a think called sin. Ok? There's a thing called sin, and it covers a plethora of things. The thing about it is that we keep side stepping what God says. The one thing I've learned along the way is that I am not the judge. I am not the judge, and I never want to play the judge. I won't do it publicly, nor privately. Thank you, Madam President.

Mrs. Blake: From the time I've come on the Commission, I've had problems with resolutions because of how divisive these types of resolutions can be. I like to recognize people for accomplishments. I don't agree with having so many recognitions of Women's Month—and I hear laughter about this—Grandparents Month. I just feel like that it becomes from early the back and forth debating on the resolutions that we take away the importance of special days and important days and events. This resolution—and we had a guest today bring up that these are our Work Session, and this is the place we should be able to have these conversations and discussions, debates. That's what we're here for. I would say we don't receive a ton of communication from our constituents, but when we do receive information and when people do come and speak, it is important for us to hear them. It's interesting. I've had people reach our to me that are in agreement with this resolution for recognizing Pride Month, and then I have had people reach out to me against this. They say that there have been some concerns and valid concerns locally about what this means. I actually live across the street from a park. There is an event every year, and I will say, I have not seen anything that is inappropriate that I would consider not wanting people to see. And I have been to event while I am a hairstylist and own a hair salon. I have been in very large cities where there have been Pride parades and events that I did find offensive it was sexual in nature. I think there is a time an da place for such activities. The activity that is at the park has not had anything like that. But I do know that this is such a divisive issue. I, as a Christian, want to be kind and helpful to everybody, but I also have beliefs that are my core values that I want to respect as well. This is just super tough. I appreciate the Commissioners that wanted to pull it out so that we honored a request from constituents. I think that this is the time to say, what does a resolution for this mean? Does this mean that we're going to find events like what we're seeing brought to our attention? There are events that are concerning. And what does this mean? Does this mean that we're going to fund events. There are things that people are afraid to say because its stuff that we never though we'd have to say in public. I have family members that are openly gay and family members that are not. I have friend that are openly gay, and friends that are not. I own a business. I recognize, and I respect everybody regardless of personal beliefs. For me, I just think that I appreciate that we can have this discussion. At times, this is very hard from what people brought and said and from what Commissioners have said. So I just want to say thank you for the people that have come and spoken and for those that have reached out to me to tell me how they feel. I, right now, I will be moving forward to move this resolution forward because I've had people reach out with both opinions, so I don't have a clear decision for my constituency, so I'm just going to be really open with that. I think that they're people that feel very marginalized. I will speak out about funding if we're funding events that are sexual in nature. As the person who's trying to help all people and figure out how to be respectful until we have a firmer stance on resolutions, I'm going to move this forward and just do some thinking this week.

It was **moved by M r. Thomas**, seconded by Mr. Jones, *that Special Resolution of Recognition for Pride Month* be moved to Thursday's agenda for consideration. Motion carried, as shown by the following roll call votes: AYES: Commissioners Blake, Burrell, Cothran, Epperson, Gage-Watts, Jones, Thomas, and G. Young (9). - *Ordinance No. 6545 of 2025, an ordinance amending the Budget of Estimated Revenues & Expenditures for the Oil & Gas and Economic Development Funds to appropriate funds for Skywest Airlines*
- *Ordinance No. 6546 of 2025, an ordinance declaring certain adjudicated properties to be surplus and to authorize the Parish Administrator, or a designee, to sell the Parish of Caddo's tax interest in certain surplus adjudicated properties and to otherwise provide with respect thereto*

At this time, there was no further discussion to come before the Commission, so the Commission adjourned at 5:17 p.m.
