### MINUTES OF THE REGULAR SESSION OF THE CADDO PARISH COMMISSION HELD ON THE 5th DAY OF JUNE, 2025

The Caddo Parish Commission met in a Regular Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mrs. Gage-Watts, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Blake, Burrell, Cothran, Epperson, Gage-Watts, Jones, Kracman, Lazarus, Thomas, G. Young, and J. Young (12). ABSENT: None (0).

Mrs. Blake gave the invocation, and Mr. Epperson led the Commission in the Pledge of Allegiance.

#### **AGENDA ADDITIONS**

It was **moved by Mr. J. Young,** seconded by Mr. Thomas, that the agenda be expanded and accept the recommendations for revisions to the NGO timeline and application be added under New Business.

Mr. J. Young said that this agenda is refinement and improvement for the NGO and economic development application process.

Mr. Burrell mentioned that this will take effect in 2026

Mr. Thomas reminded everyone that this is for updates regarding the application process as discussed in committee.

At this time, <u>Mr. J. Young's motion carried unanimously</u>, and this item was placed under New Business on the agenda.

#### **CITIZENS COMMENTS**

Sherri Fleckenstein came before the Commission and gave the following comment:

I have the privilege of leading the Shreveport free mom hugs group. Everyone at an event becomes our kid and we give high fives and hugs. but most of all, we listen. Our goal is to make our kids feel loved, seen and accepted. By formally acknowledging pride month, the city of Shreveport can do the same thing. How did I get involved? Well, several Junes ago, my own child came out and by chance I'd heard a P- flag and PACE. Luckily, someone from P- flag answered my Facebook message plea. There was a mom on the end of the line. We spoke for a little while and she told me that her child had left the area because of the lack of support in this area. This made me really sad because ugh I want my child to stay. Shreveport, has nurtured me, Shreveport has become my hometown, and I want it to be my kids' hometown too. Several minutes later, someone from PACE answered my plea, and within just a few minutes, I had a support group for my child. So, I was armed with information. A few days later, we went to that meeting and I saw my thrilled smile for the first time in months. Throughout the coming months, my child's depression lifted because they've had a place where they belonged. We were lucky, but so many other parents are not. Many of us have no idea where to go. Especially in cities that do not support pride events. According to a survey by the Trevor project in 2023 39% of our LGBTQ youth consider suicide in the past year, including 46% of transgender and non-binary young people. More than 2 in 10 LGBTQ, young people attempted suicide. Nearly half of all of our youth experience bullying. And the LGBTQ students who reported being bullied had 3 times greater odds of attempting suicide. These youth have a greater risk of suicide due to the lack of affirmation from society at large. 84% of the youth surveyed wanted mental healthcare. Over half are not able to do this and pride events such as Field Gay and Pride in the park connect people to these services. This information keeps our youth alive. And Shreveport should want to be known as a city who's interested in keeping its youth alive. Can you imagine as a young person, knowing your whole city affirms your existence? Can you imagine what that person would do for our city in the future? You know, I've never come to a pride event where I didn't feel accepted, informed, and affirmed. I would like the city of Shreveport to officially recognize pride month and to fully embody those ideals. Thank you.

Mark Nettles came before the Commission and gave the following comment:

I want to thank everyone here for this opportunity to speak. Um and first I want to say that I believe every person in this room is imperfect. Um we're all just here trying to survive and enjoy each day. Um, I also want to say I fully support the resolution and recognize Pride month and continued sporting future events allow LGBTQ plus individuals and their loved ones, living breathing, human beings, all to thrive in community. I was born and raised in Shreveport, and after moving away as a young adult for 7 years, I returned with my family to raise my children among their grandparents, aunts, uncles, cousins and old friends and also to begin my second career here as a therapist for children and adults. My parents are from the silent generation, the one between the greatest generation and the baby boomers. While um, they didn't set me up with a multimillion-dollar business takeover, um they did give me a pretty good childhood working side by side with diverse members of all communities, a lineman and a nurse. Um and even if they

haven't always understood the way others used to live, they've always been open to try. Being silent does not mean they have nothing to say, but it did mean for me the encouragement to live a Life authentically and to tend to my own concerns. My concerns today arise from my appreciation for the bravery and empathy that I've had the privilege to know through my work with the members of our local LGBTQ plus community. Every time I hear such vitriolic words about this community, like the one spoken here on Monday, my heart breaks for the youth and who just want to be seen and heard is letting breathing plaid on human beings, deserving of love and respect. When I volunteered at field gay this year, I saw people of all ages gaming with the joy of being seen, and heard that's all heteronormative allies like myself beaming with pride for their friends and loved ones, it was no surprise to me at all that I witnessed no hatred. No abuse and no coercion, but I witnessed kindness, gentleness patience, self-control, peace, love and goodness as it has been said, you will know them by these fruits of the spirit. We're living at a time when supportive communities are in great danger. when community dies, democracy dies, there are ravenous wolves and sheep's clothing who pretend to worship one master. We'll truly serve in another, they worship money and power, and they want all of it for themselves. Again, you will know them by their fruits. Their fruits are just displayed by angrily rating about protecting our children from predators, while gleefully celebrating profits from their meta stock and Tik Tok stock. To this wonderful community behind me, I want to say I see you, I hear you., and you are loved. To everyone else who does not understand or who refuses to I want to share what my mother said to me when I was a little buttheaded 8-year-old. When I was mad at her 1 day, I really leaned into the mean and I told her, I don't like you and I don't love you Does she decide and she said, I'm very sorry to hear you feel that way and I sure hope you change your mind. So, I want you all to know, and then she said, oh I want you to know that I'll always love you. Changing my mind was a simple choice after that, I'm here to try to keep us moving forward and changing our minds towards the more loving community in Shreveport thank you.

Sam Ortiz came before the Commission and gave the following comment:

I would like to begin by thanking the esteemed commissioners for their motion to proclaim June as Pride month. I stand here as someone born here and someone who has called this parish home for my entire life. I'm someone who has spent over a decade of that time actively building up my parish. In addition to that, I also serve my community as a licensed clinical social worker at a local nonprofit agency. I, along with 3 others, created Shreve Pride to provide a safe, accepting, inclusive, and positive environment for our community. Through our efforts we have been able to connect thousands of people to necessary, supports community resources, medical and mental health resources and human connection. Pride is nothing more than the fight for our ability to exist and to exist in peace. The members of our community make up vital pieces of every fabric of this region, from the people who serve us in our restaurants to the people who serve us in public office. The diversity of Caddo's people is what makes us so rich. And the LGBTQ IA plus community is part of that diversity. This month, like every month, we'll strive to uplift, we strive to heal, we strive to connect and we strive to celebrate authenticity within ourselves. We hope that Caddo Parish will be a part of that celebration, but make no mistake, Pride month is not going anywhere and neither am I.

Adrian Critcher came before the Commission and gave the following comment:

I'm a founding member of PACE, a local LGBT advocacy organization, and I'm here today to thank the commission for its past proclamations, recognizing June as pride month, and to support the passage of the resolution before you today, recognizing June 2025 as pride month. At your work session on Monday you heard from a group who used their own personal religious beliefs to implore you to vote against the pride resolution this year. Their speaker used vitriolic language to demonize LGBT people and their families, and even ask our city to deny that LGBT organizations the right to hold public events. If ever the commission needed a reason to support the LGBT community, to make a public statement against the demonization of, and discrimination against LGBT people and their families, that group provided it. Because of groups like the one you heard from on Monday, for years, being gay, lesbian, bisexual or transgender, or having an LGBT family member, was something people were afraid to talk about. This meant the only voices that people heard or the ones completely distorting and misrepresenting the lives of LGBT People, but as more and more LGBT people and their families have decided to come out and lead open, honest lives, Americans are seeing for themselves that the hateful lies that they've been told about LGBT people simply are not true. That true family values mean that all family members are loved, valued, and nurtured for who they are. These are families like mine that remain beautifully whole. I don't think your sexual orientation or your gender identity is something to be proud of or ashamed of. Most of us, regardless of our sexual orientation, or gender identity, strive to lead productive, meaningful lives and in doing so what and deserve the encouragement and support of our families, churches, and government. Yet it's too often these very institutions that reject, demonize, and every year pas laws denying basic lights to LGBT people. Yet, LGBT people still lead lives of contribution, courage and commitment, while facing senseless discrimination. Now that's something to be proud of. So, I'd encourage you once again this year to proclaim June as pride month, to recognize our wonderful LGBT community here that continues to carry on despite the attacks on it by people like the ones you heard from on Monday. Thank you.

Garrett Boyt came before the Commission and gave the following comment:

I just stand to say that LGBT people are valued and honored members of our community

at Holy Cross. Their charity, goodness, and lives bear witness to their love, their faithfulness and their thoughtfulness, despite a lifetime of hostility, declare an essential contribution to the fabric of our community. Their authenticity and sincerity to the vocation of God on their lives is such that it cannot be ignored, try as some might. And so, to the extent that this body considers the sincerely held religious beliefs of members of our community, I would just say that there are indeed many Christians in this parish who find the denigration of LGBT people on the grounds of our shared belief in Christ, to be antithetical to the teachings of the gospel, and the example of Christ. Furthermore, there are many of us, myself included, who would commend the passage of this resolution honoring the contribution of LGBT members of our community as a suitable gesture noting that the values of inclusion, cooperation, mutual affection, and care for those often derided and cast aside, are values that are at the core of pride month. And one would hope at the core of our community as well. Thank you.

Kanya Michelle came before the Commission and gave the following comment:

I'm here today as an ally in support of the pride month resolution. As a Christian woman and as a person who values all members of my community. When there are people who show up to meetings in the interest of making their neighbors feel less safe, less visible, and less valued by the community where we all live our lives together with the common goal of the thriving community. I think it's very important to show up and state that regardless of a resolution to so many of us in Shreveport, members of the LGBTQ plus community are seen, valued, and worthy of safety. Commissioners, I believe that a decision to vote against this resolution, which seeks nothing more than to celebrate queer pride, sends a message that you in your position as commissioner do not personally have interest in seeing, valuing, or caring about LGBTQ members of your Constituency. The choice in this vote doesn't seem to me to be whether or not you as an elected official charged with caring for the outcomes of all members of this parish, see yourself as an ally or even show what side you fall on in what you call a controversial issue, but whether or not you're willing to value all members of your Constituency. Regardless of their lifestyle, I hope you will all choose to vote today for the resolution in support of Pride Month to show us all that you value all members of your community. Thank you.

Lindsey Adams came before the Commission and gave the following comment:

And so we've spoken about several things here, so I'm going to kind of skip through my stuff in agreeance with previous language that has been used by the community and reasons to possibly not do this. So as pride is a nationally recognized month, we are asking for local recognition as well, which symbolizes support and inclusion for the LGBTQ plus community and extends to other marginalized groups as well. This acknowledgment costs nothing, but means everything to those who have historically been excluded and erased. One individual proposed to replace pride month with family month, it's better honor there and others faith in God. I believe this is not an either-or situation. The pride month and family month can coexist, reflecting the diverse tapestry. Another local community after all, LGBTQ plus individuals are part of families too parents, siblings, children, friends, and fellow Christians. As elected officials, you represent all residents.

Paige Hoffpauer came before the Commission and gave the following comment:

My heart is horrified to think the removal of the job core center in one of our most vulnerable areas will go forth without even a discussion. Know all that was said Monday, is this is bad. Really, really bad. Kids are being put out and there is nowhere for them to go. I saw a little clip of one of the students. Fear was in her eyes when she reported she was 38% completed with one of her trainings, and now and she and others are just being put out on the streets with no hope of completion or a brighter day Yes, this is about the children. This encompasses that if you just let me have that time, okay no problem. This should not be the case. Have you studied what it would take to keep the doors open and revamp the system? why should the federal government be paying for our children to get educated Does this follows the city's Department of Education? ..... My comrade syllabus.... This is remaining, this is responding to your work session on Monday. I'm speaking about the pickleball that item 11.11 as well as this. Okay. Could there be alliances made and networking done to reprogram this vital system in our city? But instead, you spent 45 minutes considering \$10 million pickleball, complex to be built with taxpayer money, which you will then charge taxpayers to use this doesn't seem right to me either and it's in my neighborhood, and it would be a very nice addition. What is more valuable to their city? Broken children you'll have to pay for it because you rob them of their purpose because they are not being invested in or taught to the degree that they can take care of themselves or a new pickleball complex that ultimately will grow old because the newness of it will just deteriorate with time and the facility will lose it's gleaned over the course of 10-year period like all our facilities the mayor is trying to revitalize today. No, today's important decision is here. Will we take care of our children, or will we deny the relevancy to a dying decaying city that needs them to that needs them to thrive? The answer is clear. Our hearts are with the children. The children who need your support right now at the job core center, the children who need to be safe in our neighborhood parks and public schools with authorities who believe in the sanctity of marriage, the preciousness of family is and their firm obligation as governing officials to protect these virtues in our city with all their might and strength. I'd like to ask for more time at this point. Gone are the days when we can just bluff our way through a job if you are not called here by God to rule in reign in dignity for the children, if you're a call to protect with righteous regulations and decrees, then you should not be in office here. We ask that you leave and vacate your position if you're one

of these found lacking today. I'm not sure it would be a bad thing just an honest thing. Sometimes we acquire wealth or status to our own demise to save yourself today. So, save yourself today. Leave office if you're not here for the moral and judicial reason God would have you here. Repent and turn back. God will heal you and help you recover with newfound direction and a hope for tomorrow's real, is that real for tomorrow, that's real full of purpose and impact. not niceties and affliction because you're really not qualified for or registering the importance of what this government seat of authority demands. God will replace you with the caring the loving the strength he has in individuals. He has gifted them with to do the job at hand. For those of you who are moral, thank you, I believe your vote, your voting will show that today those of you who are immoral, relieve your position. So, a man or woman appointed to the task by God, you can come in and make virtuous decisions. I say these words with great honor and respect for all of you sitting in the here today. We are all at work in progress and God is not finished with any of us yet. Praise God. I mean all of this with his heart and love for each of you each and every one of you sincerely with gods encouragement to you today. But you are making decisions that affect generations today. The 300 kids being exported today out of the safety of the job course center. The hundreds of thousands of kids who need restoration of the family, husband and wife as protection and role modeling and money that if it's available for pickleball complex at this time, it is certainly available for more righteous matters that are needed first. Perhaps later on the pickleball complex. I am for entertaining ways to stay physically fit, but let's invest in our children today. Vote, no typical ball complex, but no to LGBTQ pride month and though, and vote yes to using work meetings to find viable solutions to meet the current crisis and needs of our city's vital functioning. Thank you for hearing me out today respectfully yours, Paige Hoffpower, Thank you.

WHEREAS, on Wednesday, May 28, 2025, the City of Shreveport, under the leadership of Mayor Tom Arceneaux, in collaboration with Sportran, led by Executive Director Dinero Washington, will dedicate a bus

stop in honor of Patrina Jenkins at the corner of Hearne Avenue and North Market Street—a location symbolic of access, visibility, and community; and.

WHEREAS, this act of remembrance was made possible through enabling legislation cosponsored by Shreveport City Council Chair Tabatha Taylor and Councilman Jim Taliaferro, demonstrating the City's deep commitment to lifting up the lives and legacies of those who serve our most vulnerable neighbors; and

WHEREAS, this level of influence would carry on through 60's soul legends like Brenton Wood, whose songs have found renewed viral success on social media, soul artist Margie Evans, and Estelle Brown of the Sweet Inspirations who has been inducted into the Graceland Hall of Fame for her legendary accompaniment of Elvis Pressley carry on a musical legacy alongside modern artists like drummer/producer/manager Brady Blade, electronic trailblazer DJ Yoshi, rapper Hurricane Chris, country artist and Beyoncé collaborator Willie Jones, indie rock's genre defying AJ Haynes & the Seratones, and the living legend, Grammy awarded Jazz drummer Brian Blade.

WHEREAS Shreveport's own "Losing Boy," Eddy Giles (whose daughter Stephanie Lynch served on the Caddo Commission and Shreveport City Council) and Reuben Bell were among the artists to define and give birth to Southern Soul, a sound that would evolve in the hands of Quenn Echols, Crystal Thomas, Tanji Jefferson, Jeter Jones, P2k Dadiddy, Ronald Slack Jefferson, Ron Johnson, Sweet Nay, and many more Southern Soul artists who continue to make our community the heartbeat of this musical style.

Mr. Thomas gave the following statement regarding this issue:

I rise today in support of legislation that acknowledges Pride Month in Caddo Parish, not as a political statement, but as a reflection of our shared humanity and the values of dignity, respect, and inclusion that every citizen deserves. Some have referenced Scripture in opposition to this recognition, pointing to verses from Leviticus or other parts of the Old Testament. And I want to say clearly: I am no stranger to the Word. I grew up in church. I still walk daily with Christ. And because of that walk, I've spent time wrestling with Scripture—not to weaponize it, but to understand it more deeply. The Old Testament gives us many laws. Some of them are severe. Some are difficult to reconcile with how we live today. According to those same texts, touching the skin of a dead pig is considered unclean-yet on any given Sunday in Louisiana, we cheer for our favorite team as they play football, which is made from just that. Other laws prohibit trimming your beard, wearing mixed fabrics, or eating shrimp and pork. Yet many of us, myself included, have enjoyed a good barbecue or lined up for gumbo, not fearing eternal consequence. What this teaches us is not that the law is wrong, but that it was written for a people in a particular time, under a theocracy, not a democracy, and that it pointed forward to something greater. That "greater" is Jesus Christ. Jesus said, "I have not come to abolish the Law, but to fulfill it." He walked among outcasts. He sat with the marginalized. He challenged the self-righteous and stood with the oppressed. And ultimately, He gave His life, not for some sins, but for all sin. That includes mine. That includes yours. That includes everyone. Because of Him, I strive to lead with compassion. Because of Him, I believe in extending grace to others just as I have received it. And because of Him, I cannot stand silent when members of our community are dismissed, devalued, or denied recognition of their humanity. This resolution does not call anyone to change their beliefs, abandon their faith, or compromise their convictions. It simply says that the people of Caddo Parish see our LGBTQ+ neighbors, and we choose to treat them with the respect every human being deserves. To affirm someone's dignity is not to deny God. In fact, I believe it is to reflect Him more fully. I have no desire to allow fear mongering to have rise, and that fear has had already had consequences. In our own backyard, here in Caddo Parish, transgender women have been murdered simply for being who they are. I want to pause and honor their memory:

- Pooh Johnson, a beloved 25-year-old makeup artist.
- Brooklyn DeShauna Smith, a 20-year-old cosmetology student with a bright future.
- Vontashia Bell, just 18 years old when her life was taken.
- Valerie "Ms. Val" McKinney, a woman who deserved to grow old with dignity.
- Terry Golston and Freddy Henderson, whose names we say today to ensure they are not forgotten.

So, as we enter Pride Month, let us remember: Jesus taught us to love our neighbor. Not just the easy neighbor. Not just the one who looks like us or believes like us. But every neighbor. And as a man of faith, I believe that kind of love is the foundation of righteous leadership. Allow me to invoke the courage of Ms. Pamela Raintree when she boldly proclaimed to the city council in 2011 that he who has not sinned, I welcome you to take this stone and cast it upon me first.

For a \$250k home, it would be an additional \$82 per year, if this ordinance were to pass. She said that the increase is intended to fund criminal justice system needs.

Mrs. Bryant also explained that Ordinance No. 6535 maintains the current levels.

WHEREAS, it is necessary for the Caddo Parish Commission (the "Commission") acting as the governing authority of Caddo Parish, Louisiana (the "Parish"), to levy various taxes for the year 2025; and

WHEREAS, it is necessary to adjust the Parish millages as a result of the quadrennial reappraisal and valuation of the property subject to taxation within the Parish, in proportion to the increase in the 2025 taxable assessed valuation of the Parish;

WHEREAS, a public hearing was held by the Commission on the subject of the proposed millage adjustment in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution of 1974 and LA R.S. 47:1705(B).

NOW, THEREFORE, BE IT ORDAINED, by the Caddo Parish Commission, in due, legal and regular session convened, that the following general purpose and special millages (that is, fractional mills on the dollar) on the assessed valuation of all property subject to taxation in the whole of Caddo Parish, Louisiana be and the same are hereby levied at the following adjusted rates for the year 2025, in accordance with Article VII, Section 23(C) of the Louisiana Constitution of 1974 and LA R.S. 47:1705, as applicable:

WHEREAS, on May 15, 2015, the Parish of Caddo sold Refunding Bonds in the total aggregate sum of \$6,850,000; and

WHEREAS, on February 25, 2015 the Parish of Caddo sold Refunding Bonds in the total aggregate sum of \$6,345,000; and

WHEREAS, on May 19, 2016 the Parish of Caddo sold Refunding Bonds in the total aggregate sum of \$7,250,000; and

WHEREAS, on March 29, 2023 the Parish of Caddo issued general obligation bonds in the total aggregate sum of \$20,000,000; and

WHEREAS, it is necessary to levy a millage tax for the year 2025 in order to pay the principal and interest on said bonds, which will fall due in the year 2025.

NOW, THEREFORE, BE IT ORDAINED, by the Caddo Parish Commission, in due, legal, and regular session convened, that a special tax of 1.5 mills on the dollar on assessed valuation of all property subject to taxation within the whole of Caddo Parish, Louisiana, be and the same is hereby levied for the year 2025, for the purpose of paying principal and interest which will become due in the year 2025 on the aforesaid public improvement bonds and refunding bonds.

BE IT FURTHER ORDAINED, that the Commission Clerk shall give notice of this ordinance to the Assessor of Caddo Parish, Louisiana, and instruct him to levy and assess each tax as set forth herein for the year 2025.

BE IT FURTHER ORDAINED, that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED, that this ordinance shall take effect ten (10) days after publication in the official journal.

BE IT FURTHER ORDAINED, that all ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED, that this ordinance shall take effect ten (10) days after publication in the official journal.

BE IT FURTHER ORDAINED, that all ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT ORDAINED, by the Caddo Parish Commission in due, legal, and regular session convened, that the Caddo Parish Commission hereby adopts any and all assessments covering property owned by railways, tank car lines, and other public service corporations, and that the values named, fixed and reported be accepted and adopted as the values for all Parish purposes.

BE IT FURTHER ORDAINED, that the Commission Clerk shall give notice of this ordinance to the Assessor of Caddo Parish, Louisiana, and instruct him to levy and assess each applicable tax millage upon these values as set forth herein for the year 2025.

BE IT FURTHER ORDAINED, that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED, that this ordinance shall take effect ten (10) days after publication in the official journal.

BE IT FURTHER ORDAINED, that all ordinances or parts thereof in conflict herewith are hereby repealed.

It was **moved by Mr. Thomas**, seconded by Mr. Epperson, that Ordinance No. 6536 of 2025, an ordinance to set the General Purpose and Special Purpose Millages providing for an increase in the millage rates not in excess of the prior years maximum rates, as allowed by Article VII, Section 23 of the Louisiana Constitution of 1974 and LA R.S. 47:1705 (B), levying and imposing taxes and assessments for 2025 on all the property subject to taxation in the Parish of Caddo, and to otherwise provide with respect thereto be adopted.

- Mr. J. Young said that Ordinance No. 6536 of 2025 increases millages to the maximum rate authorized by the voters. This increase is address jail overcrowding, inmate medical costs, juvenile justice resources, and other related criminal justice issues. He also mentioned that the public allowed the Commission to charge this amount. Public safety needs to be restored, he said.
- Mr. Cothran wanted to know how long it has been since the Commission has raised the rates to the maximum allowed rate. Mrs. Bryant explained that the reassessments are done every four years. The last time this was done in 2001. A financial plan was presented to the Commission to help address criminal justice issues.
- Mr. G. Young wanted to know how much this would generate. Mrs. Bryant said that this would generate approximately \$700k, but they expect this number to grow due to new properties being added to the rolls.

Mr. Atkins said that any time the underlying value of the properties increase, revenues increase as well. Mrs. Bryant explained that an individual taxpayer who has maintained their homes since 2001 should not have seen an increase from the Parish. She also said that the costs of projects have double, and so have the materials.

WHEREAS, a public hearing was held by the Commission on the subject of the proposed millage adjustment in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution of 1974 and LA R.S. 47:1705(B).

WHEREAS, SkyWest Airlines is headquartered in St. George, Utah with a fleet of over 500 aircrafts connecting passengers to 262 destinations throughout North America; and

WHEREAS, SkyWest Airlines, the nation's largest regional airline carrier, has selected Shreveport Regional Airport as its newest maintenance base and facility to help support its fleet; and

WHEAREAS, the SkyWest facility is expected to create 150 direct new jobs with an average annual salary of \$70,000 as well as an estimate of an additional 375 indirect jobs, bringing a total potential of new jobs to 525; and

WHEREAS, the Parish of Caddo would like to appropriate \$250,000 to SkyWest Airlines as part of the incentive package offered for locating at the Shreveport Regional Airport; and

WHEREAS, it is necessary to amend the 2025 Budget in order to transfer \$250,000 from the Oil and Gas Fund to the Economic Development Fund to provide an appropriation for SkyWest Airlines.

NOW, THEREFORE, BE IT ORDAINED, by the Caddo Parish Commission in due, legal and regular session convened, that the Budget of Estimated Revenues and Expenditures for the Oil and Gas Fund and the Economic Development for the year 2025 are hereby amended as follows:

WHEREAS, the Bond Commission, on May 15, 2025, duly authorized the issuance and sale of the Bonds in accordance with law and the Bond Commission's Rules and Regulations; and

WHEREAS, the Bonds are classified as exempt facility bonds under the provisions of the Internal Revenue Code of 1986, as amended (the "Code") and the provisions of Section 147(f)(2)(A), (B) and (E) of the Code require that issuance of Bonds be approved by the "applicable elected representative" of the governmental unit which issues such bonds or on whose behalf such bonds are issued and by the "applicable elected representative" of such other Participating Jurisdictions that have executed a CEA with the Authority under the provisions of the Act; and

WHEREAS, Caddo Parish (the "Governmental Unit") has executed a CEA with the Authority to permit the financing of loans to first-time homebuyers within geographic area of the Governmental Unit; and

WHEREAS, the applicable elected representative (the "Approving Representative") of the Governmental Unit for purposes of approving the Bonds is Caddo Commission President Stormy Gage-Watts and

WHEREAS, in compliance with the requirements of the Code, Notice of Public Hearing (attached as Exhibit "A" hereto), was published in (i) The Advocate, Baton Rouge, Louisiana on April 23, 2025, (ii) The Daily Advertiser, Lafayette, Louisiana on April 23, 2025, (iii) the Houma Courier, Houma, Louisiana on April 23, 2025, (iv) the Lake Charles American Press, Lake Charles, Louisiana on April 23, 2025, (v) The News Star, Monroe, Louisiana on April 23, 2025, (vi) the Times-Picayune, New Orleans, Louisiana on April 23, 2025, (vii) The Times, Shreveport, Louisiana on April 23, 2025, and (viii) The Town Talk, Alexandria, Louisiana on April 23, 2025, and

The Authority, and its officers, are authorized to cause this certificate to be filed of record in the transcript of proceedings for the Bonds and to file a copy thereof with any State or Federal agency, board or commission as may be required by any applicable State or Federal laws, rules or regulations.

She came back before the board because she got out again in April and attacked another dog. Lucy's owner, Ms. Allison McKneely, is willing to take steps to prevent future incidents.

Ms. McKneely does not want her dog to be put down, but she understands that her dog hurt another dog. Ms. McKneely said that Lucy is not people aggressive at all, but she does have a high prey drive.

Mr. Thomas said that this puts the Commission in a hard place because it is their duty to protect citizens, but he wanted to know what she is willing to do to protect the humans of this Parish. Ms. McKneely said that she will do anything to ensure that people are safe and that Lucy is safe, like building a stronger fence, muzzling her, and exercising her more.

It was **moved by Mr. Epperson**, seconded by Mr. J. Young, to uphold the decision of the board and deem Lucy vicious.

Mrs. Blake wanted to know Lucy's demeanor when she was brought in. Mr. Clark said that she was not aggressive towards people. He also mentioned that the stipulations of her being deemed dangerous was not being followed.

Mr. J. Young said that it is sad when a dog loses their life. He also said that this dog has killed another dog, which is sad as well, but the citizens have to be protected.
