On Saturday 01/18/2025 at approximately 11:25 a.m. I arrived at 4449 Finley Dr in reference to an enforcement.

Upon arrival, I made contact with the victim, Mr. Nathaniel Mattison, who advised me of the incident. He stated that while his wife, Mrs. Megan Mattison, and him were walking their dog down Finley St, they observed 2 dogs at large. 1 large white Pit Bull mix dog and 1 smaller brindle Pit Bull mix dog. He stated that after they saw the dogs, they switched sides of the street to keep distance. He stated that the larger white Pit Bull mix dog ran up and charged at them. He stated that he yelled at the dog and the dog stopped. He stated that the dog again charged and began to attack their dog. He stated that his dog received several lacerations and puncture wounds. He stated that he was also scratched on the right arm, but it did not break the skin. He stated that his wife is currently at the Animal Emergency Clinic off of Line Ave. When asked if he would fill out a CPAS Witness Statement Form, he agreed. An additional CPAS Witness Statement Form was left for Mrs. Mattison. I made contact with Mrs. Mattison via phone who asking her to send a copy of the animal's medical report and send photographs of the dogs injuries. She understood.

After speaking with the Mattison's, I arrived at 4337 Finley St. and made contact with Mr. John Worthey and Mr. Duane King who witnessed the incident. Mr. King stated that he was walking his dog and passed the Mattison's on Atlantic Ave. He stated that shortly after he passed them, he arrived at the corner of Leo Ave and stopped. He stated that he heard them yelling and then observed a dog run across the street towards them. He stated that it was 1 large white Pit Bull mix dog. He stated that he observed the dog jump on the Mattison's and their dog. When asked if he would fill out a CPAS Witness Statement Form, he agreed.

After speaking with Mr. King, I made contact with Mr. Worthey who stated that at the time of the incident he was in his backyard. He stated that he heard a loud commotion and dogs barking. He stated that he came to his front porch and saw two dogs attacking the victim's and their dog. He stated that the dogs then ran down the street. He stated that the 1 large white Pit Bull mix dog was running down the center of the street and the 1 brindle Pit Bull mix dog was running down the sidewalk. He stated that he observed 1 silver Toyota Tundra, License Plate #Z667240, stop near the dogs and the brindle one ran up to it. He stated that he is not sure if the truck is involved in the incident. While speaking with Mr. Worthey I received a call from the Call Center regarding 1 white Pit Bull mix dog matching the description currently at 4344 Clingman Dr growling and charging at individuals in the area.

I then arrived on Clingman Dr and observed 1 large white Pit Bull mix dog at large. Dog appeared to be in fair health with no collar or tags. I made several attempts to capture the dog but was unsuccessful. The dog ran in the backyard of 4306 Clingman Dr. and ran inside the house through the opened backdoor. Door had no doorknob. A neighbor exited their house at 4305 Clingman Dr and stated that the dog resides at the residence. He stated that they also have 1 brindle Pit Bull mix dog. He stated that the dogs used to get out frequently, but it hasn't happened since around July. He stated that he has contacted the dog owners and advised them that their dogs are at large. I then retrieved the suspects contact information. Due to the dog running inside the residence, I closed the door and secured the door utilizing a leash. A door notice was posted advising to contact CPAS regarding the dog running loose.

After posting the notice, the resident, Ms. Allyson Jennings, from 4317 Clingman Dr made contact with me stating that the dogs have been running loose all morning. She stated that the 1 large white Pit Bull mix dog attack and killed a neighbor's dog. She stated that she drove the neighbor to the Animal Emergency Clinic and they determined the dog was deceased. She stated that the dog died from a broken neck. When asked if she would fill out a CPAS Witness Statement Form, she agreed.

After speaking with Ms. Jennings, I made contact with Ms. Miranda Larocca from 4338 Clingman Dr. who is the owner of the deceased dog. She stated that she observed 1 brindle Pit Bull mix dog running loose in her yard at approximately 9:45 a.m. She stated that she attempted to see if the dog owners were home, but she then saw the 1 white Pit Bull mix dog also at large. She stated that the brindle dog ran off, so she started trying to get the white Pit Bull mix dog to their home. She stated that she stopped at her house and the dog followed her. She stated that she attempted to shove the dog away when entering her residence, but the dog broke into her living room and began to attack her dog by violently shaking it. She stated that she was able to get her dog away from the other dog, but it again grabbed her dog and shook it. She stated that she was finally able to remove the neighbor's dog from her living room. She that her dog was unresponsive, so she and her neighbor took the dog to Animal Emergency Clinic, and they determined that the dog was deceased. When asked if she has any photographs of her dog after the incident, she stated that she did not. When asked if she would fill out a CPAS Witness Statement Form, she agreed.

After speaking with Ms. Larocca, several individuals who were remodeling the house at 4334 Clingman Dr made contact with me. Mr. Conner Gearlds stated that they have seen the 1 white Pit Bull mix dog at large. He stated that the dog growled and tried to bite him last weekend. When asked if he would fill out a CPAS Witness Statement Form, he agreed.

While retrieving the CPAS Witness Statement Form's, the suspects arrived on scene. Ms. Allison Mckneely and Mr. Jacob Gillen. Mr. Gillen was irate and demanding we let his dogs off my service vehicle. I advised him that we do not have the dogs in custody. I explained

to both individuals that the dogs were running loose, killed a dog, attacked a dog, and scratched an individual. I advised them that the 1 white Pit Bull mix dog ran into their house, and I secured the door. Mr. Guillen stated that he rather go to jail then let us take his dogs. Mr. Guillen then ran to his residence. Ms. Mckneely stayed with me and explained that they left their residence around 9:00 a.m. and their car broke down. She stated that they were able to get a ride back from a stranger to check on their dogs. When asked who the dogs belong to, she stated that the 1 white Pit Bull mix dog belongs to her and the 1 brindle Pit Bull mix dog belongs to Mr. Gillen. Ms. Mckneely then went back to her residence to retrieve her driver's license. I then arrived at 4306 Clingman Dr and Mr. Gillen was still yelling and being irate. Mr. Gillen then stated that he took the dog through the backyard and to the next street over and placed it in his parents' vehicle. Mr. Gillen then fled the scene on an electric scooter. I contacted Shreveport Police Department and multiple units arrived on scene to assist. I again made contact with Ms. Mckneely and issued her City Summons #3104 for the following violations: 14-36(a) At Large Dogs, 14-16(4)(d) and (2) Owner Responsibilities. She understood and apologized for the incident and Mr. Guillen behavior. I advised her that CPAS will be seizing the dogs and for the violations. She understood.

I then patrolled the area and observed 1 brindle male Pit Bull mix dog running at large on Finley Dr. The dog appeared the be in fair health with no collar or tags. Mr. Worthey verified that the dog was the one involved in the incident. Dog fled to the suspects residence at 4306 Clingman Dr and went into the suspects backyard. The backyard was in violation due to being improperly enclosed. Dog was captured and placed on my service vehicle. Unable to scan for a microchip. Dog impounded at CPAS. I cleared the scene. Additional files added to files tab. Babbs/ Bute
