## **Vicious Dog Case Synopsis**

1/18/2025 Lucy and another dog named Zeus were at large. 1 dog was attacked while being walked on a leash in the area. Injured dog was taken to Animal Emergency Clinic. Another citizen Miranda Larocca stated that she observed 1 brindle Pit Bull (Zeus) mix dog running loose in her yard at approximately 9:45 a.m. She stated that she attempted to see if the dog owners were home, but she then saw the 1 white Pit Bull mix dog also at large. She stated that the brindle dog ran off, so she started trying to get the white Pit Bull (Lucy) mix dog to their home. She stated that she stopped at her house and the dog followed her. She stated that she attempted to shove the dog away when entering her residence, but the dog broke into her living room and began to attack her dog by violently shaking it. Dog was pronounced deceased by Veterinarian.

Lucy and Zeus were both impounded following these events. Owners agreed to the Dangerous Dog stipulations and repaired/ reenforced /built a backyard fence to contain the dogs. Dogs were released 2/10/2025.

4/28/2025 at large dog attack by previously Deemed Dangerous Dog. Victim dog was being walked on a leash but sustained injuries during the attack, seen by Vet. Dog was brought to CPAS by owner following the event.

5/13/2025 8:41 a.m. attempted to make contact with Jacob Gillen at 318-469-4038 regarding Lucy. Left voicemail. 5/13/2025 3:12 p.m. owner Allison Mckneely, (318) 469-4038 returned my call and advised that she would like to proceed with the Animal Services Board. I advised that the dog will be up for a vicious dog determination. A. McKneely mentioned constructing a front gate as the dog will exit through the front door, I advised to wait and go through the Board as they could request that stipulation but it's currently unknown if the dog will be deemed vicious and not return to the property. The dog will remain in custody until the board convenes. T. Clark

On Friday 5/16/25 at approximately 939 am, I arrived at 4306 Clingman Dr to follow up. Upon arrival, I made contact with owner (Jacob Gillen). Owner stated he did not agree with the decision of CPAS to deem his dog (Lucy) 1 white Pit bull vicious. Notification/ receipt documents were signed. Owner was educated on the vicious dog ordinances. Owner stated he plans to build a front fence in the next 2 weeks. I cleared the scene. Washington/Thompson

5/22/2025 2:06 p.m. Animal Services Board upheld Vicious Dog determination. Dog owner is said to want to appeal. Current fees and appeal process notice was hand delivered to dog owner via E. Baker.

Lucy has been impounded for 38 days x \$13 daily for boarding totaling \$494 in fees.
