WITNESSETH

WHEREAS, the above individual acknowledges that he/she is the owner of an animal which has bitten or scratched as defined by Caddo Parish Ordinance Section 4-9 No. 4395 of 2005 of the Caddo Parish Commission;


WHEREAS, Caddo Parish Animal Services is unable to properly quarantine said animal as the animal is outside of the Parish jurisdictional boundaries;


In consideration of the above-identified animal, it is agreed that Allison McKneely shall defend, indemnify and hold harmless the Parish of Caddo, any municipality which has adopted an animal control ordinance substantially similar to the above-referenced ordinance, and all of their officers, agents, servants and employees from and against any and all claims, demands, suits, losses, damages, judgments, costs and expenses, whether direct, indirect or consequential and including but not limited to all fees, expenses and charges of attorneys, and other professionals, as well as court and mediation costs and

expenses, for bodily injury, including death, personal injury and property damage, arising out of, in connection with or resulting from the actions of the above-identified animal.





