

MINUTES OF THE MEETING OF THE
CADDO PARISH COMMISSION'S
APPROPRIATIONS COMMITTEE
HELD ON THE 6th DAY OF JANUARY, 2025

The Caddo Parish Appropriation Committee met in legal session on the above date at 1:05 p.m., in the Government Plaza Chambers Conference Room, with Mr. Cothran, presiding, and the following members in attendance: Commissioners Blake, Burrell, Cothran, Gage-Watts, Epperson, and Thomas, (6). ABSENT: Commissioner J. Young (1).

The Pledge of Allegiance was given by Mr. Epperson and invocation was given by Mr. Cothran.

There being no Citizen's Comments or Agenda Additions, the Committee moved to New Business.

NEW BUSINESS

- *Discussion regarding NGO Appropriations process*

The committee met and discussed the appropriations process. The spoke on organizations that had an emergency on the middle of the year and how that affects the processing. The committee hope to come to a consensus.

It was mentioned that VYJ and Hope Connections were some of the organizations that had midyear emergencies and requested additional funding.

It was recommended not to have a second round of funding; organizations should be able to request their needs in the initial application.

Mr. Epperson Mentioned with good budgeting the organizations shouldn't need more funds as an NGO. They should plan accordingly budget and be organized.

Mr. Burrell mentioned that unless an emergency comes up mid-year that is not an additional program, the organization should wait til next year's funds unless it's related to the Parish business.

Mr. Cothran asked, "What is considered an emergency?" The suggestions shouldn't come directly to the Parish. It was also suggested to explain to the organization they are outside of the funding processing time. The goal is to keep the actions in consensus with the Parish rules.

Mr. Epperson mentioned that it is time to wean some of the organizations that are past the cycle. Mrs. Blake asked why couldn't a mid-year be sat up. It was advised that there is a one-time application. The problem is additional amounts that aren't emergencies. As a collective, all agree on the definition of an emergency.

It was mentioned that the vote doesn't have limitations. The request can still happen and the administration will work on the language. This would be on a per-case basis; any applications approved outside of the process have to go through the appropriations committee

It was moved by Mr. Commissioner Thomas, seconded by Mrs. Commissioner Gage-Watts, to recommend to the full body to strike the no media rule from the application. The motion carried, as shown by the following roll call votes: AYES: Commissioners Blake, Burrell, Cothran, Gage-Watts, Epperson, and Thomas(6). NAYS: None (0). ABSENT: J. Young (1). ABSTAIN: None (0).

- *Discussion regarding NGO Education Seminar*

Mr. Thomas would like to set up an educational seminar to educate those past and present applicants. The applicants should no the process of grant writing and processes. The administration questioned about the host and Mr. Thomas advised a co-host to provide input and share the educational burden.

The seminar will not only be on how to complete the application process but grant writing and how to get funding from other entities and the proper way to get those funds. Mr. Burrell mentioned that the private sector is a safety net and network. Year to year organizations are withdrawing. Mr. Thomas proposed a private sector can setup at the seminar.

Mr. Burrell also mentioned the language once more and how some places, if it's not written correctly the organization won't receive a dime. Mrs. Gage-Watts encouraged the idea and hope this will be a success.

It was moved by Mr. Commissioner Thomas, seconded by Mrs. Commissioner Gage-Watts, to recommend to the full body to explore a NGO education seminar.
