

MINUTES OF THE WORK SESSION  
OF THE CADDO PARISH COMMISSION  
HELD ON THE 21<sup>ST</sup> DAY OF JANUARY, 2024

The Caddo Parish Commission met in a Work Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mrs. Gage-Watts, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Burrell, Cothran, Epperson, Gage-Watts, Kracman, Lazarus, G. Young, and J. Young (9). ABSENT: Commissioners Blake, Jones, and Thomas (3).

The invocation and Pledge of Allegiance were given during a previous committee meeting; there were no Agenda Additions, Citizens Comments or Visitors, so the Commission moved onto Reports.

**ADMINISTRATOR REPORT**

- Keep Louisiana Beautiful

Mrs. Bryant said that the Parish received five trash receptacles through the grant.

Mr. Epperson asked if there were photos of the receptacles and Mrs. Bryant advised she would provide those to him.

- Juvenile Detention

Mrs. Bryant said that there are twenty children in the Juvenile Detention Center; three of which are OJJ. There are three 17-year-olds and 460 children on probation.

**SPECIAL RESOLUTION OF RECOGNITION AND APPRECIATION  
2025 MLK, Jr. DAY OF SERVICE RESOURCE FAIR**

WHEREAS, the Reverend Dr. Martin Luther King Jr., a towering figure in the history of civil rights and social justice who delivered his famous “Speech at Galilee” right here in Caddo Parish, dedicated his life to advocating for equality, service, and community unity, leaving behind a legacy that continues to inspire millions worldwide; and

WHEREAS, the Martin Luther King Jr. Day of Service Resource Fair exemplifies Dr. King’s enduring call to action for individuals to engage in meaningful acts of service to uplift their communities and foster collaboration; and

WHEREAS, this event, organized with dedication and care by the Mystic Krewe of Imani and other community leaders, embodies the spirit of unity and service that Dr. King championed, empowering individuals and families to build stronger and more connected communities; and

WHEREAS, the Martin Luther King Jr. Day of Service Resource Fair serves as a testament to the collective efforts of Caddo Parish residents to honor Dr. King’s legacy by fostering engagement, understanding, and positive change;

NOW, THEREFORE, BE IT RESOLVED, by the Caddo Parish Commission in legal and regular session convened, that it does hereby recognize and commend the Martin Luther King Jr. Day of Service Resource Fair for its outstanding contribution to the community, its commitment to honoring Dr. King’s legacy, and its dedication to promoting service, equality, and unity among the citizens of Caddo Parish.

- Mr. Burrell introduced his grandson to the Commission and advised that he was babysitting today.


## CONSENT AGENDA
