MINUTES OF THE REGULAR SESSION OF THE CADDO PARISH COMMISSION HELD ON THE 6th DAY OF FEBRUARY, 2025

The Caddo Parish Commission met in a Regular Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mrs. Gage-Watts, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Blake, Burrell, Cothran, Epperson, Gage-Watts, Kracman, Lazarus, Thomas, and J. Young (12). ABSENT: Jones and G. Young (2).

The invocation and Pledge of Allegiance were given in a previous committee meeting. There were no Agenda Additions, so the Commission move onto Citizens Comments.

CITIZENS COMMENTS

Calvin Pressley came before the Commission and gave the following comment:

Thank you for the opportunity to communicate about the extension of Dawson Road. I'm speaking on behalf of Ms. Laura Timberlake, who has lived on that street for over 30 years, that I know of. She probably paid a significant amount of tax in that period of time for her portion. There's some money on the table, I understand, to extend that road between Jefferson Paige and I-20—or close to I-20. I rise and ask you to please open that road up due to the flooding—severe flooding—in that neighborhood. Any questions?

Brad Driggers came before the Commission and gave the following comment:

I'm here to speak in opposition of Ordinance No. 6513 today. I'm not sure about what's going on with Dawson Road, but I do know what's going on with the Greenwood water system. We would appreciate it if y'all would leave those funds allocated to Greenwood to help our water system.

Mark Dickerson came before the Commission and gave the following comment:

I'm in opposition to extending the road and wish the funds would remain with Greenwood to help our water system. Our ground towers are in critical condition, and they need to be replaced.

Mr. Coleman came before the Commission and gave the following comment:

I am here today in opposition of Ordinance No. 6513 of 2025.

Jodie Larson came before the Commission and gave the following comment:

I am in opposition of Ordinance No. 6518 of 2025. I'd like y'all to really consider that and the Town of Greenwood really needs our water system updated. I'd just like to aske that y'all please reallocate that money to the water system. It's in need of repairs and quality water. Thank you.

ADMINISTRATION REPORT

Response to Commissioners Request

Parish Administrator, Mrs. Erica Bryant, said that Administration has been working with the Caddo Council on Aging and hopes to have the Wheelchair Ramp Program up and running by February 24, 2025. She also said that Administration has reached out to the City regarding property standards and should be prepared for the upcoming Committee meeting.

COMMUNIQUES & COMMITTEE REPORTS

• Mr. Epperson said that the Public Safety Committee met and discussed the roles of the

Citizens Disaster Committee and their response plans for weather related events, such as tornado and other natural disasters. Mr. Epperson further stated that efforts are underway to educate the public about available services and aid. Data is being collected to provide a booklet of resources for the Citizens Disaster Committee.

Mr. Epperson then talked about the legacy left behind by the passing of Joe Shyne. He said that the Student's Oath of Commitment to Education was written in 1987 and was highly regarded by Mr. Shyne, so much so, that he requested a copy of the oath to display in his classroom. Mr. Epperson said that he still uses that oath to this day and provides copies to students, parents, and teachers.

- President Gage-Watts turned the meeting over to Mr. Epperson due to a scheduling conflict that she has to be at.
- Mr. Atkins asked to speak with Mr. Alan Clark after this meeting regarding some future development in his district.
- Mr. Burrell also talked about Mr. Shyne. He never met a stranger, he said. Mr. Burrell said that Mr. Shyne's interactions with people were impactful, and his contributions to the City Council were noted as significant. Mr. Burrell offered condolences to the family and friends of Mr. Shyne.
- Mr. Thomas said that the Appropriations Committee met today. Productive discussions occurred concerning the appropriations process, and the conversation is ongoing. Mr. Thomas offered condolences to the family and friends of Mr. Shyne, Mr. Caldwell, and Pastor Austin.
- Mr. Cothran offered condolences to the family, friends, and students at Southwood to fellow classmate Kam'ron Lee, who passed away.
- Mr. Epperson reminded the Commissioners to submit their various trainings. He also mentioned that the Pines Road Area Business Association will hold a meeting on February 24, 2025 at 6:00 p.m. He encouraged all to attend.

There was no President's Report nor Public Hearing on Zoning Ordinances & Cases, so the Commission moved onto Public Hearing on Ordinances.

PUBLIC HEARING ON ORDINANCES

President Gage-Watts opened the public hearing on the following ordinance:

Ordinance No. 6513 of 2025, an ordinance amending the Budget of Estimated Revenues & Expenditures for the Capital Outlay Fund to change an appropriation from the construction and improvement of Greenwood water lines to the construction of the Dawson Road extension, and to otherwise provide with respect thereto.

Kirby Dawson came before the Commission and spoke in favor of Ordinance No. 6513 of 2025 and gave the following comment:

I'm strongly supporting this thing for Dawson Road to be extended. Its been up before you guys before—I think in 2015—what funds were allocated [inaudible] and for whatever reason it was rescinded. As a thing that keeps coming to the board over and over again. I don't think people understand how [inaudible] it is, but when it is flooding, you can't get out, and you trapped in, and people try to get to school. Its an ongoing thing. It's a problem. I think we have an opportunity right now to do the right thing, and I think that's to extend it.

Michi Arima came before the Commission and spoke in favor of Ordinance No. 6513 of 2025 and gave the following comment:

Now, I might sound like I have a slight accent, but I grew up in Shreveport in ol' Lakeside, ok? I picked berries right over there—I probably sound Minnesotan now. Ok, so I left off and went to school in California and came back. I tried to go to school again and went to the service. I went around the planet in one direction and in the other direction, alright? I got out after Desert Strom and came back home because I'm country, ok? Everybody in my family are what they call citified—I'm countrified, ok? So even though I left out and I was up north, I came back down—it took me awhile to get my y'all and draw to come back. I've been down here since 2010. Now, I do recall when they came out and wanted to possibly extend Dawson Road, alright? It was feasible at the time, ok? I'm here to tell you—I live way back up in the woods, Louisiana, ok? Dawson Road only goes a mile in—once you get there, you hang a right, you go another quarter mile, and that's where I'm at, ok? Off the grid. That's Section 16. Dawson Road is Section 9—one mile long, right? SWEPCO and AEP came through and upgraded the high voltage lines. I hope the clock ain't ticking because I'm long winded, y'all. Alright. They upgraded—went from them long telephone poles and replaced them with the big metal ones, ok? That's all fine. I'm back up in the woods. I got trees in front

of me, but when they cleared it out, I'm looking at a telephone pole. Well I said, "count my blessings because the folks on Jefferson Paige got them right in their front yard." If you can imagine going east to west, coming out of Texas, but with these high voltage lines, ok? Go all the way into town. Now, what they did was AEP went north and south and came up and intersected right at the end of Dawson Road. Now, in order to do that, they need—I guess you could call it easement or right-of-way? But, one minute, it was woodscousin over here, they'll tell you-one minute it was woods; next minute, a whole swatch! A hundred feet wide, ok, with these 70 foot poles—I got to know them poles very well, ok? They go all the way down, then they do a dog leg at Section 21, continue on down to Greenwood Road. Now you got a 100 feet, ok? Before it wasn't feasible to come down to Dawson Road because it was this wide, ok, with a little ditch on the side. They fixed it up a little bit, but that expression, God-willing, and the creek don't rise—I got hip waders, ok? There's a law that when that intersection down there floods, school buses cannot come to there, ok? I stood on one side with the parents. I'm yelling at the school because they cannot come through those waters, ok? They shored it up—the bridge down there, we count our blessings—they shored that up, but we haven't had as strong of rain to bring it up, but it still comes up and over the road. That's on that end. Down at the other end, this is where I'm at, so when all those waters come in, they fill in Paige Bayou and feed into it. That's where it comes together and goes that way north toward the lake. So at this end, like I said, you got 100 feet wide—I've seen some streets in town that are just wide enough for a car and a car here, ok? Enough is paved to where the postal service can go and turn around. Now, we're out there—I have one elder neighbor that a quarter of a mile [inaudible] where her mailbox is up there. He's way back here, and they can't go because before it was dirt. I think they graded it with gravel. Now, its paved. If 18 wheelers can go down there, you know, postal service should be able to come down there with her mailbox. Now, from there, the road is only so wide--pave it, go down to Dawson Road, excuse me, Greenwood Road and that's a done deal, ok? And I apologize to the folks, you know, who have issues with their drinking water. You know when we have one way in and out—I care about my neighbors, the ones who need emergency services to come in, ok? What happens if we have another Snowmageddon like we did two years ago? What happens if we have freezing weather—the emergency response? They can cover so much, but then we still fall into a grey area. It's al great and good when the sun is shining, ok? Just—you know, you got alleys in town that aren't as wide or wider, but then ours, you know? What's a little tar? I grew up with tar streets in town where you ran barefoot when it was hot. So what's up? You know, we could all chip in and just to have another way because of the elders that are out there. I'm talking like they're old—I'm up there too! I'm gonna be an elder when I grow up, ok? So you got them out there, you could need emergency stuff out there. If the power goes out—and it does, you know, getting in and out of there, just think about it. You know, how would you take care of your neighborhood? It's not in your yard, so it doesn't-not in your backyard, so it doesn't come? But I was hesitant to get up because if my neighborhood over here is in need of assistance, and my neighbors over there need assistance—I go, 'wait a minute, I gotta step back. I gotta be true.' That's how I live to take care of my neighbors because one day, when I roll into Greenwood, I'll bump into them, who knows? We might cross paths. So out of all of that, I guess you kinda caught wind that I'm for this. Ok, I'm done talking. Thank you so much.

There being no one to speak in favor, or against, this ordinance, the President closed the public hearing. There were no Zoning Ordinances for final passage, so the Commission moved onto Ordinances for final passage.

ORDINANCES (for final passage)

It was **moved by Mr. Epperson**, seconded by Mr. Burrell, that Ordinance No. 6513 of 2025, an ordinance amending the Budget of Estimated Revenues & Expenditures for the Capital Outlay Fund to change an appropriation from the construction and improvement of Greenwood water lines to the construction of the Dawson Road extension, and to otherwise provide with respect thereto be postponed until the February 20, 2025 Regular Session.

Mr. Epperson said that a phone conversation between him and Mayor Davis revealed the need for more dialogue. He would like this postponement to ensure accurate information is provided prior to a final vote. Mr. Epperson said that he is a strong advocate for positive initiatives within in his district.

Mr. Atkins mentioned that funds were allocated, and a study was completed, but the study indicated that building a road would be sub-economic at that time. That was the reason it wasn't built in 2015, he said.

Mr. Epperson placed an emphasis on economic development, safety, convenience, and quality of life improvements as it relates to Dawson Road and its residents. He would like to work in a collaborative effort to address the concerns of the citizens in his district.

Mr. Burrell agreed and said that there have been concerns regarding road conditions and accessibility, included past incidents of buses getting stuck.

The Clerk of the Commission explained that this ordinance will be re-advertised in the Official Journal informing the public of the new public hearing.

WHEREAS, the Parish of Caddo is a Lessor in that certain oil, gas and mineral lease from the Caddo Parish Commission to Cypress Energy Partners, LLC., in State Agency Lease #22252, dated November 13, 2024, and recorded at Registry No. 2992868 of the Conveyance Records of Caddo Parish, Louisiana; and

WHEREAS, the Parish of Caddo is a Lessor in that certain oil, gas and mineral lease from the Caddo Parish Commission to Cypress Energy Partners, LLC., in State Agency Lease #22253, dated

November 13, 2024, and recorded at Registry No. 2992869 of the Conveyance Records of Caddo Parish, Louisiana; and

WHEREAS, the Parish of Caddo has received a written request from Cypress Energy Partners, LLC, seeking approval from the Parish of Caddo of an assignment, bill of sale and conveyance of State Agency Leases No. 22252 and No. 22253, from Cypress Energy Partners, LLC, to Paloma Natural Gas, LLC, and

WHEREAS, this approval is expressly granted and accepted subject to the requirement that all terms and conditions of the basic lease will be fulfilled, including but not limited to the full payment of rentals and royalties, regardless of the division of leasehold interests resulting from the instrument.

NOW, THEREFORE, BE IT RESOLVED by the Parish of Caddo, in due, regular and legal session convened, that the Administrator is hereby authorized to approve the assignment, bill of sale and conveyance of State Agency Leases No. 22252 and No. 22253 from Cypress Energy Partners, LLC, to Paloma Natural Gas, LLC.

BE IT FURTHER RESOLVED if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict herewith are hereby repealed.
