The Caddo Parish Commission met in a Regular Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mrs. Gage-Watts, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Blake, Burrell, Cothran, Epperson, Gage-Watts, Jones, Kracman, Lazarus, Thomas, J. Young, and G. Young (12). ABSENT: None (0).

Student Commissioner, Marcello Sessum gave the invocation, and Student Commissioner McKenzie Jefferson led the Commission in the Pledge of Allegiance.

AGENDA ADDITIONS

It was **moved by Mr. Epperson**, seconded by Mr. Thomas, *that the agenda be expanded and Special Resolution of Remembrance for Billy Montgomery* be added under Special Resolutions.

Mr. Burrell offered condolences to Mr. Montgomery's family and friends. He highlighted his contributions to the community, especially his work during Hurricane Katrina. Mr. Burrell asked that the Commission support this agenda addition.

At this time, Madam President Gage-Watts opened the floor for anyone to speak in favor or against adding this item to the agenda. There being no one to speak, the public hearing was closed.

At this time, Mr. Epperson's motion carried unanimously.

CITIZENS COMMENTS

Jon Glover came before the Commission and gave the following comment:

You know, it is an exciting moment for me to go through the agendas to see exactly what is here to me, a citizen of Caddo Parish needs to gain knowledge about. I am ever grateful with that, and in doing my own homework, I gained an understanding matter of what's going on. I can even reach out to some you Commissioners when it is necessary to gain more information. Now, I do recognize that there's a concern for me here. There are two pieces of ordinances that you all are going to consider for introduction, 6538 and 6539. Now, the language of those legislations is what bothered me more than anything, particularly, the assessing for the whole year of 2025 from whomever these areas will affect when it is that you all will not adopt these pieces of legislation. And though it has been common practice that you go back to the beginning of the year, I'm trying to figure out why would you go back and assess me? Say for instance, if it is that you decide on June 5th to adopt this legislation—five months that you did not cover me or that I would not be covered. What is that all about? I just don't understand the integrity of that account, you know, practices may have been. It doesn't mean they have to be. It can be changed if there is something that's worthy of your attention and you're willing to look at what it is again, going back to the beginning of the year to assess me all the way to December when you've only adopted this legislation June 5th. If someone between now and June 5th can bring that logic to me, then it may help me to appreciate what is truly going on. Thank you.

ADMINISTRATION REPORT

Mrs. Bryant confirmed that citizens who are attending Council Meetings or Commission Meetings will not have to go through the whole process of signing in and getting their photos taken.

PRESIDENT'S REPORT

Mrs. Gage-Watts wished everyone a Happy Easter.

There were no Public Hearing for Zoning Ordinances, so the Commission moved to Public Hearing on Ordinances.

PUBLIC HEARING ON ORDINANCES

Madam President Gage-Watts opened the public hearing on the following zoning ordinances:

 Ordinance No. 6526 of 2025, an ordinance amending the Budget of Estimated Revenues & Expenditures for the Oil & Gas Fund and the Riverboat Fund to provide an appropriation of \$30,000 for Youth Outreach Services dba Jewell House, and to otherwise provide with respect thereto

Jon Glover came before the Commission and gave the following comment:

I'm here to speak to Public Hearing for Ordinance No. 6526. Not just Monday, but even when this piece of legislation will walk before you, the members of the Commission, questions were asked. A presentation was presented and answers were given, but I still have some questions that have not been asked. We do understand that these \$30k are to survive for 90 days, and that they're supposed to be addressing six girls. Six girls. I'd like to know, as I did ask before, what are the specifics of those things that those \$30k for those six girls will address? Two, I saw that the funding is not readily available out of the Riverboat Fund—it has to be transferred from the Oil & Gas Fund. Why is that necessary? Is there not sufficient funding the Riverboat fund to address the \$30k versus going to the Oil & Gas Fund. It's just some questions that I have that I'd like to have answers to. Though, you will be addressing this later in this setting is just something that I think requires some consideration. Thank you.

Ms. Fisher came before the Commission and spoke in favor of Ordinance No. 6526 of 2025 and gave the following comment:

Good afternoon, everyone. I'm sorry—I don't have a voice today. I have a sinus infection, but I am certainly in favor of taking care of our most vulnerable population: our kids. And making sure they

have a safe, secure place to stay safe, and that they have food—three meals a day—if they have clothing, that they have the necessary things that they need for school, and that they have a sufficient amount of counseling and support services that are provided with these funds. We're open 24 hours a day, 7 days a week. This it to take care of our staff, and I pay my staff a very minimum. If you look at some other budgets of other staff persons, they are paid a little bit more, but because of the need, they have decided to take on this. This is not just a job for them; this is a ministry for them. Thank you.

- Ordinance No. 6527 of 2025, an ordinance declaring certain adjudicated properties to be surplus and to authorize the Parish Administrator, or a designee, to sell the Parish of Caddo's tax interest in certain surplus adjudicated properties, and to otherwise provide with respect thereto
- Ordinance No. 6528 of 2025, an ordinance to donate surplus property under Chapter 19, Article II, Division 3 of the Code of Ordinances, relative to the donation of adjudicated property acquired by the Parish under LA.R.S. 47:2236 et seq., to authorize the donation of property to the City of Shreveport, and to otherwise provide with respect thereto

There being no one else to speak in favor, or against, the ordinances, the President closed the public hearing. There were no Zoning Ordinances for final passage, so the Commission moved onto Ordinances for final passage.

ORDINANCES (for final passage)

It was **moved by Mr. Jones**, seconded by Mr. Thomas, that Ordinance No. 6526 of 2025, an ordinance amending the Budget of Estimated Revenues & Expenditures for the Oil & Gas Fund and the Riverboat Fund to provide an appropriation of \$30,000 for Youth Outreach Services dba Jewell House, and to otherwise provide with respect thereto be adopted.

Mrs. Gage-Watts mentioned that this is the only shelter that houses young women. It provides more than a shelter; it provides counseling, educational programs, and life skills training, she said. Due to the federal cuts, services like these are being disrupted. She requested that the Commissioners support this ordinance for emergency funds.

Mr. Atkins recognized that these are emergency funds, and that there are provisions in the NGO process that allows for emergency funds to be provided. He also recognized the importance of the services being provided. He asked Mrs. Bryant for a brief explanation of the flow of capital through the funds. Mrs. Bryant explained that they prefer to keep the fund balance at a certain level, so they are recommending a transfer to keep that fund balance.

At this time, Mr. Jones' motion carried unanimously.

ORDINANCE NO. 6526 OF 2025

BY CADDO PARISH COMMISSION:

AN ORDINANCE AMENDING THE BUDGET OF ESTIMATED REVENUES AND EXPENDITURES FOR THE OIL AND GAS FUND AND THE RIVERBOAT FUND TO PROVIDE AN APPROPRIATION FOR YOUTH OUTREACH SERVICES D/B/A JEWELL HOUSE AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, Youth Outreach Services is a 501(3)c non-profit organization providing guidance and direction for youth in northwestern Louisiana; and

WHEREAS, the Caddo Parish Commission appropriated \$10,000 to Youth Outreach Services in the 2025 budget; and

WHEREAS, Jewell House is a transitional living facility ran by Youth Outreach Services; and

WHEREAS, the Caddo Parish Juvenile Detention Center has limited capacity and partners with other agencies to provide temporary housing to juveniles as an alternative to detention; and

WHEREAS, the Caddo Parish Commission would like to appropriate an additional \$30,000 to Youth Outreach Services d/b/a Jewell House for temporary housing of juvenile girls on probation as an alternative to detention; and

WHEREAS, it is necessary to amend the 2025 Budget of the Riverboat Fund and the Oil and Gas Fund to provide an appropriation for temporary housing of juveniles; and

NOW, THEREFORE, BE IT ORDAINED, by the Caddo Parish Commission in due, legal and regular session convened, that the Budget of Estimated Revenues and Expenditures for the Riverboat Fund and Oil and Gas Fund for the year 2025 are hereby amended as follows:

Budget Increase (Decrease)

Riverboat Fund:

Youth Outreach Services \$30,000 Transfer From Oil and Gas \$30,000

Oil and Gas Fund:

Transfer to Juvenile Justice \$30,000

BE IT FURTHER ORDAINED, that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provisions, items or applications, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED, that this ordinance shall take effect upon adoption.

Mr. Thomas applauded Mrs. Gage-Watts for bringing this resolution forward. He encouraged the Student Commissioners to let their peers know that they are "under attack". He wished everyone much success.

RESOLUTION NO. 25 OF 2025

BY THE CADDO PARISH COMMISSION:

A RESOLUTION OPPOSING SENATE BILL 74 OF THE 2025 REGULAR LEGISLATIVE SESSION OF THE LOUISIANA LEGISLATURE RELATING TO THE ADULT PROSECUTION OF JUVENILES AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, Article 302 of the Louisiana Children's Code provides that special juvenile courts created by law for Caddo, Orleans, Jefferson, and East Baton Rouge Parishes shall have exclusive original jurisdiction over juvenile proceedings; and

WHEREAS, Senate Bill 74 of the 2025 Regular Session of the Legislature proposes to divest the special juvenile courts of jurisdiction over any person that commits a crime before his **fifteenth** birthday and give that jurisdiction to district and city courts; and

WHEREAS, the proposed law effectively lowers the maximum age of persons to whom

juvenile procedures shall apply; and

WHEREAS, such lowering will increase the case loads in district courts as well as the jail populations in adult facilities; and

WHEREAS, studies show that juveniles housed in adult facilities face increased risk of physical and emotional harm; and

WHEREAS, Louisiana law already provides for the adult prosecution of juveniles for the most serious offenses; and

WHEREAS, the Caddo Parish Commission opposes lowering maximum age of persons to whom juvenile procedures shall apply.

NOW, THEREFORE, BE IT RESOLVED by the Caddo Parish Commission that it does hereby oppose Senate Bill 74 and urge the legislature to not adopt that legislation.

BE IT FURTHER RESOLVED that a copy of this resolution be sent, following adoption, to the Louisiana Legislature and to the members of the legislative delegation of Caddo Parish.

Public Hearing for I-49 North Corridor Economic Development District Resolution No. 2 of

2025:

 A resolution establishing a sales tax within the boundaries of the I-49 North Corridor Economic Development District in connection with the PILOT agreement with Edgemont Holdings, LLC, and otherwise providing with respect thereto

Mayor Kim James came before the body in favor or I-49 North Corridor Economic Development District Resolution No. 2 of 2025 and gave the following comment:

I'm here today on behalf of, not only the people of Hosston, but many residents, business owners, and voters across District 1 who have signed a petition that I have here today in support of the 2% sales tax at the TA Express in Hosston. This isn't about a business; it's about a promise. Years ago, this very Commission made a commitment to support the development of the I-49 Corridor. That commitment helped incentivize Edgemont Holdings to take a chance on our community. They came in and invested private dollars to build infrastructure, which were water, fiber, electric, gas, and road access—things that many of us waited years to see in this part of the Parish. For too long, this part of the Parish has been overlooked when it comes to development. We've watched other areas grow while we've struggled with limited access, limited services, and limited opportunity. When Edgemont Holdings came in, they didn't just come to build a truck stop, they invested in us when no one else would. And, they did it with the understanding that there would be a path of reimbursement through the public partnership, one that wouldn't cost taxpayers a dime up front. That's what the 2% sales tax does, it keeps the promise. This tax applies only to the TA Express location. It's not a burden on our local residents. It's a way to repay the investment that brought real tangible improvements to the part of the Parish that has long been underserved. We all want growth; we all want jobs; we all want our kids to have a reason to stay here in our small towns, to build lives and start businesses of their own. That won't happen if we don't support people and companies who are willing to take the first step. I urge this Commission to vote in favor of the 2% sales tax, not just to reimburse Edgemont Holdings, but to show that Caddo Parish stands by its word, and that District 1 is not forgotten. Thank you for you time, and thank you for listening to the voice of the rural communities.

Alderman for Hosston came before the body in favor or I-49 North Corridor Economic Development District Resolution No. 2 of 2025 and gave the following comment:

We would like for you all to please consider voting for this tax. Our community needs this tax. We need growth in our community, we pray that you consider that when you're voting today. Thank you.

Hosston Chief of Police, Jessie Costum, came before the body in favor or I-49 North Corridor Economic Development District Resolution No. 2 of 2025 and gave the following comment:

I came there and ran for that position this past year after serving six years as Chief of Rodessa. The reason why I ran was because of the excitement and the growth that was looking toward Hosston. Hosston was on life support, and this TA Truck Stop came in and got them off life support, so they can do what they're doing today. Our Mayor is not—that is her people. She's lived in that community for 36 years. Those people shop together; they go to the store together; they go to church together. That is her people. That's where she's rooted. I know the word "political suicide" has been thrown around here and there, and I think its political suicide not to approve this in honor of—your words, our words—in honor of Todd Hopkins. He was a great man who put a lot of blood, sweat, and tears in making this happen.

There being no one to speak in favor or against, the President closed the public hearing.

It was **moved by Mr. Thomas,** seconded by Mr. Cothran, that I-49 North Corridor Economic Development District Resolution No. 2 of 2025, a resolution establishing a sales tax within the boundaries of the I-49 North Corridor Economic Development District in connection with the PILOT agreement with Edgemont Holdings, LLC, and otherwise providing with respect thereto be adopted.

Mr. Thomas reminded that these funds received from this tax will only be used in that particular area to grow Hosston. He also reminded the Commission that the NGO funding comes from the revenues that are collected from riverboat casinos.

Mr. Jones talked about Mr. Thomas' character. He would like to keep things professional around the horseshoe without personal attacks on another Commissioners' character. Mr. Jones would like to work together in a positive manner.

Mr. Kracman pointed out that he has no control of what the local papers print; he has no control over what a PAC puts forward; and he has not said anything about another person's character. Mr. Kracman also mentioned that the majority of the signatures on the petition were from citizens of Vivian, not Hosston.

Mr. G. Young gave a historical perspective of District 1 and how it relates to his family. He also mentioned that everyone around this horseshoe is part of what Caddo Parish's future will look like.

Call for the Question by Mr. Cothran, seconded by Mrs. Gage-Watts. <u>Motion carried unanimously by those members who were present with Commissioner J. Young being absent (1)</u>.

I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT RESOLUTION NO. 2 OF 2025

A RESOLUTION ESTABLISHING A SALES TAX WITHIN THE BOUNDARIES OF THE I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT IN CONNECTION WITH THE PILOT AGREEMENT WITH EDGEMONT HOLDINGS, LLC, AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, Part II, Chapter 27, Title 33 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 33:9038.31, *et seq.*) (the "*EDD Act*") authorizes municipalities, parishes and certain other local governmental subdivisions to create economic development districts to carry out the purposes of the Act, which economic development districts are political subdivisions of the State of Louisiana and possess such power and authority and have such duties as provided by the EDD Act and other law; and

WHEREAS, the Section 33:9038.39 of the EDD Act permits economic development districts to levy sales taxes for authorized purposes in addition to any other sales taxes then in existence or permitted to be in existence therein, and provided that in the event there are no qualified electors in the district in question, as certified by the Registrar of Voters, no election shall be required prior to the levy of such sales taxes; and

WHEREAS, pursuant to the EDD Act, the Caddo Parish Commission, acting as the governing authority of the Parish of Caddo (the "*Governing Authority*"), adopted Ordinance 6193 of 2022 on March 3, 2022, which created **THE I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT** (the "*District*"), in accordance with La. R.S. 33:9038.32; and

WHEREAS, when the district was created, certain improvements within the district were made by the sole occupant of the district, the Rocking R Truck Stop, who benefits from a PILOT agreement until the costs of those improvements are reimbursed; and

WHEREAS, a two-cent sales tax in the district would significantly shorten the period of time within which the reimbursement can be made, and bring the full taxable value of the Rocking R Truck Stop onto the Caddo Parish tax rolls.

NOW, THEREFORE, BE IT RESOLVED, by the Caddo Parish Commission acting as the governing authority of the I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT in due, regular and legal session convened, that the Caddo Parish Commission, acting as the governing authority of the I-49 NORTH CORRIDOR ECONOMIC DEVELOPMENT DISTRICT, does hereby authorize the levy and collection of a two cent sales and use tax upon the sale at retail, the use, the lease or rental, the consumption and storage for use or consumption, of tangible personal property and any other property

which may be subject to sales and use tax in the State of Louisiana now or in the future and on sales of services in the District for a period commencing on May 1, 2025 and ending on May 31, 2032, all in the manner and subject to the provisions and terms of those portions of Title 47 of the Louisiana Revised Statutes of 1950, as amended, applicable to sales and use taxes levied by the District for the purposes of funding construction of, acquisition of, and upgrades to capital improvement and economic development projects within the District's boundaries and any and all authorized purposes under the applicable provisions of Part II, Chapter 27, Title 33 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 33:9038.31, et seq.).

BE IT FURTHER RESOLVED, that the Caddo Parish Administrator or his designee shall be authorized to do any and all things necessary to effectuate the purposes set forth herein.

BE IT FURTHER RESOLVED, that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications which can be given effect without the invalid provisions, items, or applications, and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER RESOLVED, that this resolution shall become effective immediately upon publication in the official Caddo Parish Journal.

NEW BUSINESS

It was **moved by Mr. Epperson**, seconded by Mr. Thomas, *that Crystalline Whitaker Nelson* be appointed as the Caddo Parish Poet Laureate.

Mr. Thomas said that she will be announced during ArtBreak.

COMMUNIQUES & COMMITTEE REPORTS

- Clerk's Note: Notice is hereby given pursuant to Article 7, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B) that a public hearing the Caddo Parish Commission will be held at its regular meeting place in Chambers of Government Plaza, located at 505 Travis Street, Shreveport, LA on Thursday, June 5, 2025 at 3:30 p.m. to consider levying additional or increased millage rates without further voter approval or adopting the adjusted millage rates after reassessment and rolling forward to rates not to exceed the prior year's maximum. The estimated amount of tax revenues to be collected in the next year from the increased millage is \$27,020,360.87, and the amount of increase in taxes attributable to the millage increase is \$1,198,364.04.
- Mr. Epperson thanked the Public Works Department for providing him information with regards to a property within his district. He also announced that a Dollar General will be constructed on Pines Road and Jefferson Paige Road.
