MINUTES OF THE WORK SESSION OF THE CADDO PARISH COMMISSON HELD ON THE 5th OF MAY, 2025

The Caddo Parish Commission met in a Work Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mrs. Gage-Watts, presiding, and the following members in attendance constituting a quorum: Commissioners Blake, Burrell, Cothran, Epperson, Gage-Watts, Kracman, Lazarus, Thomas, G. Young, and Mr. J. Young (10). ABSENT: Commissioners Atkins and Jones (2).

The invocation and Pledge of Allegiance were given during previous committee meetings.

AGENDA ADDITIONS

It was **moved by Mrs. Gage-Watts,** seconded by Mr. Thomas, that the agenda be expanded and the following items be added under New Business:

The President opened the floor for anyone to speak in favor or against this public hearing.

Jon Glover came before the Commission and spoke on the agenda addition:

As I am not knowledgeable of these items that you all have brought forth. I can definitely understand the special recognition for Doug Williams. The Project Boneyard—I don't know what that is, but I'd like to get an explanation as what you all be addressing with regards to this. I do understand that 6543 is a zoning matter that's in District 2; 6544 is in District 7—is it a zoning matter as well? So, if you could share that information, I would truly appreciate it. Thank you.

There being no one else to speak, the President closed the public hearing.

At this time, Mrs. Gage-Watts' motion carried unanimously by those members present with Commissioners Atkins, Burrell, and Jones being absent (3).

There were no Citizens Comments nor Visitors, so the Commission moved onto the Administrator Report.

ADMINISTRATOR REPORT

Juvenile Detention

Parish Administrator, Erica Bryant, said that there are fourteen children in the Detention Center; six of which are OJJ. There are two 17-year olds, and twenty-three children at CCC. There are 456 children on probation.

Mr. J. Young asked about the juveniles being housed at CCC. He requested additional information for the children at CCC.

He then wanted to know how many people are incarcerated at CCC. Mrs. Bryant said that there are 1,499 people at CCC. Mr. J. Young wanted to know if there were any plans to alleviate the population at CCC. Mrs. Bryant said that there are ongoing conversations.

Walter B. Jacobs

Mrs. Bryant invited the Commissioners to attend a tour of the Walter B. Jacobs facility. This tour will be held on May 21. She asked that the Commissioners be at Government Plaza on that date at 9:00 a.m. An overview of the exhibits will be provided on May 22.

Rabies & Microchip Clinic

Mrs. Bryant announced that 368 rabies vaccinations were given and 256 microchips were given during the most recent Rabies Clinic.

Sandbags

Due to the chance of inclement weather and an increased chance of flash flooding, Mrs. Bryant said that the Parish of Caddo will be offering citizens fifteen sandbags today and tomorrow. Citizens can pick them up at 1701 Monty Street from 7:30 a.m. until 3:30 p.m.

COMMISSION REMARKS

- Mr. Thomas asked for a moment of silence for the passing of community activist Mrs. Bessie D. Smith. He will provide her homegoing service information as he receives them.
- Mr. J. Young mentioned that there is a serious situation at CCC with regards to overcrowding.
- Mr. Cothran announced that C.A.R.E. rescheduled their meeting to May 19 at A.B. Palmer Park.
