Young (10). ABSENT: Commissioners Jones and J. Young (2).

The invocation and Pledge of Allegiance were given during previous committee meetings. There were no Agenda Additions nor Citizens Comments, so the Commission moved onto Visitors.

Lorenzo Davenport
 Who's Next Barbershop

The Commission commended Who's Next Barbershop and its owner, Mr. Lorenzo Davenport, for their dedication to the youth of Caddo Parish, particularly for providing free haircuts at a back to school event. The Arc of Caddo-Bossier

The Arc of Caddo-Bossier presented it programs and divisions, emphasizing its role in workforce development by supporting individuals with disabilities and their families. The Arc highlighted its partnerships, community integration efforts, and the positive impact on the lives of those served. They are requesting a bigger ask this year of \$100k to support its programs, including Goldman School, GREAT program, community homes, and Frost Industries.

Several Commissioners thanked the Arc for the great work they are doing in the community.

 Alexis Svehla Robinson's Rescue

Ms. Svehla thanked the Commission for its support, which has enabled the organization to provide affordable and free spay/neuter surgeries. Robinson's Rescue operates several programs, including affordable spay/neuter, subsidized spay/neuter incentive program (SNIPP), as well as education and outreach. Their efforts have led to a significant decrease in shelter intake and euthanasia rates in the Parish.

 Beth Smiley American Rose Center

The American Rose Society is facing financial challenges due to declining membership and is seeking support to continue its operations, particularly the annual Christmas in Roseland event. The American Rose Center contributes significantly to the community through education, preservation of roses, and hosting international rose trials. Ms. Smiley advised that they will need to raise \$125k by the end of September to ensure the Christmas in Roseland event can take place this year.

Budget Retreat—September 12, 2025

Administrator Bryant announced that the budget retreat is scheduled for September 12, 2025.

Juvenile Detention Center census

Administrator Bryant said that there are 22 children in the Detention Center, five of which are OJJ, and four 17 year olds. There are 422 children on probation and twenty juveniles are at CCC.

There were no Commission Remarks, so the Commission moved onto the President's Report.

At this time, Mr. Cothran's motion to englobo and advance carried unanimously with Commissioners Jones and J. Young being absent (2).

It was **moved by Mr. Atkins,** seconded by Mr. G. Young, that Ordinance No. 6548 of 2025, an ordinance amending the Budget of Estimated Revenues & Expenditures for the Debt Service Fund and the Capital Outlay Fund to provide an appropriation of \$10M for the construction of a pickleball park, and to otherwise provide with respect thereto be moved to Thursday's agenda for introduction. Motion carried, as shown by the following roll call votes: AYES: Commissioners Atkins, Blake, Burrell, Epperson, Gage-Watts, Lazarus, Thomas, and G. Young (8). NAYS: Commissioners Cothran and Kracman (2). ABSENT: Commissioners Jones and J. Young (2). ABSTAIN: None (0).

It was **moved by Mr. Cothran,** seconded by Mr. G. Young, *that the Commission convene into Executive Session to discuss Caddo Suit #659061.* <u>Motion carried unanimously with Commissioners Jones and J. Young being absent (2).</u>

At this time, only specified members were allowed in the Chambers for this discussion. Everyone else was dismissed.
