

**MINUTES OF THE WORK SESSION
OF THE CADDO PARISH COMMISSION
HELD ON THE 2nd DAY OF FEBRUARY, 2026**

The Caddo Parish Commission met in a Work Session, on the above date, at 3:30 p.m., in the Government Chambers, with Mr. Gregory Young, President, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Blake, Burrell, Cothran, Epperson, Gage-Watts, Jones, Kracman, Lazarus, Thomas, G. Young, and J. Young (12). ABSENT: None (0).

Mr. Jones gave the invocation, and Mr. Thomas led the Commission in the Pledge of Allegiance. There were no Agenda Additions.

CITIZENS COMMENTS

Melissa Beckett came before the Commission and gave the following comment:

Thank you for allowing me to speak. My name is Melissa Beckett. I actually live in Texas, just across the border. I am running to be the state representative for that area. My address is 3771 Harley Ridge Road, Longview, Texas 75604. I'm here today in support of the resolution urging that the Red River Compact Commission and Louisiana Department of Energy and Natural Resources place a moratorium on the withdrawal of water from Caddo Lake for any use other than small commercial or residential use and to otherwise provide with respect thereto any studies or anything that might be necessary in order to determine whether or not there's actually additional water that can be taken out. You might wonder why I'm here. Well, Caddo straddles Texas and Louisiana, which I'm sure you know, and the residents of Texas are very concerned about additional water being taken out of Caddo. And I know we all have a lot that we need to think about when it comes to these data centers. Are they needed? Yes. Where should they be? And the things that I'm hearing from the people just right across the border are that they moved to these places that are more rural because they didn't want to be around things like the data centers, the light, the hums, all the things that come with that. And I think as elected officials, I'm not there yet, but I intend to be. We should always be thinking about the people who currently exist in this space and are affected by the decisions. Are they going to benefit from this? And my struggle is whether it be here or right across the border, electric prices going up does not help our constituents. Water prices going up and becoming more scarce do not help our constituents. And creating a space that is no longer rural does not help our constituents. And I would just, I'd beg you to accept this resolution. Vote on it unanimously. Choose the citizens who love where they live. And really think about requiring businesses to be good neighbors. Requiring them to pay property taxes so that burden doesn't fall on the citizens. Requiring them to set up shop in a way that does not impact the citizens, especially those that live out at Caddo and those that come to visit. Thank you so much for the opportunity to be here. I appreciate you very much. Thank you.

These do not include the service interruptions that last less than 24 hours. On 10/15/24 the mayor said updates to the water system membranes will increase our output from 4.5 millions gallons to almost 6 million gallons per day! "12/23/22 - I just received an update from our Utilities Manager concerning the water system during this polar freeze! Due to having customers home water dripping/running to prevent freezing the water plant is stressing to keep our elevated tanks at full capacity. The guys are having to turn the valves to 50% in some areas to allow certain tanks to fill. The areas that will be affected with lower water pressure are : Lowery Rd. Stateline, Blanchard Furr, Longwood, North Lakeshore south of Blanchard Furr." Please do not let the data center be built out here as we can not take further strain on our water system.

Ie; Blanchard Utility, AEP, or UOP/Honeywell. They all can keep on business as usual. This only addresses the outtakes of water from Caddo Lake on a mass scale in the *future*. Setting any bias or emotion aside and airing on the side of intelligence. Knowing that we don't know everything. We'll implore the experts to do their work. This doesn't hurt anyone involved. It's better to know now, than wait for it to hit us like a ton of bricks. I appreciate anyone's support in advance. And as always, please reach out with any questions or concerns.

VISITORS

- *Dr. Joseph Jones
North Louisiana Crim Lab System*

Dr. Joseph Jones, Director of the North Louisiana Crime Lab, appeared before the Commission and offered to answer questions.

Mr. Atkins asked Dr. Jones to explain how the Crime Lab is addressing ongoing funding challenges, including whether the lab expects to continue operating at a loss or reach a break-even point. Dr. Jones explained the lab serves 29 northern parishes and that funding has been difficult for decades due to reliance on court fees. He stated court-fee revenue has decreased compared with earlier years (referencing amounts around \$7M in 2017 vs. approximately \$3.7M–\$4.3M in more recent years). It costs roughly \$6M annually to operate the lab, leaving a recurring gap he must close each year through a combination of legislative support, external clients, and other stopgap measures. He described extraordinary efforts made to keep operations stable, including community support and short-term financial measures.

Additional questions addressed whether there is momentum for a long-term legislative funding mechanism. Dr. Jones said traction is difficult without unity among parishes. Cost comparisons and case volume, including that Caddo Parish represents a significant portion of the caseload (approximately 4,000 cases out of roughly 16,000), with a discussion of "per case" cost comparisons to national figures. Dr. Jones explained that participation by all parishes/courts in paying court costs and the challenge of ensuring all relevant courts (including smaller municipal courts) consistently contribute.

Mr. Burrell asked whether another crime lab (Acadiana) would compete with the North Louisiana Crime Lab. Dr. Jones stated it serves a different region but faces similar operating-cost problems.

Dr. Jones encouraged stronger legislative action and collaboration, noting Caddo's unique position with three appointed commissioners to the Crime Lab board. Mr. Atkins suggested adding this issue to the Commission's legislative priorities.

Dr. Jones invited the Commissioners to tour the Crime Lab to better understand operations and funding needs.

ADMINISTRATOR REPORT

- Juvenile Detention Center census

Administrator Bryant said that there are 13 children in the Detention Center, and no 17 year olds. There are 391 children on probation. Eleven juveniles are at CCC.

- Winter Weather Update

Administrator Bryant thanked staff and partners for coordinated efforts during inclement weather and stated an after-action review is underway to identify improvements. She also noted continued work assisting residents dealing with storm aftermath.

Mr. Cothran raised concern about ID requirements reported in news coverage during the storm, asking whether local facilities required identification for entry and whether the Parish should develop supports to help residents obtain IDs. Administrator Bryant stated the issue would be included in the after-action list.

Mr. J. Young noted that the Parish's Lighthouse sites did not require ID for entry during the storm.

COMMISSION REMARKS

- Mrs. Gage-Watts called for an Economic Development Committee meeting for Thursday at 2:00 p.m.

PRESIDENT'S REPORT

President G. Young offered brief remarks recognizing the relative success of the storm response, emphasizing outcome-based assessment and "all hands on deck." Appreciation was extended to commissioners for district communications and participation in coordination calls, and to administration for ongoing leadership during the event.

There being no Old Business, the Commission moved onto New Business.

It was **moved by Mr. Kracman**, that *Resolution No. 8 of 2026, a resolution urging and requesting that the Red River Compact Commission and the Louisiana Department of Energy & Natural Resources (LDENR) place a moratorium on the withdrawal of water from Caddo Lake for any use other than small commercial or residential use, and to otherwise provide with respect thereto. Motion died to the lack of a second.*

It was **moved by Mrs. Gage-Watts**, seconded by Mr. J. Young, that *Citizens Comments and Communiques be taken up prior to the Commission convening into an executive session. Motion carried unanimously with all Commission members present.*

CITIZENS COMMENTS

Vickie Moore came before the Commission and gave the following comment:

Good afternoon. I appreciate the opportunity to speak to y'all before you recess or officially recess. As a citizen of Caddo Parish for 47 years, I spent 45 of those in Shreveport. I was a Shreveport citizen. When I retired after working in hospitals for over 50 years, I retired out in the Blanchard area. My address is 7835 Blanchard Latex Road, Shreveport 71107. That of course changed my representation on this Commission. When you do not live within the city limits, you do not have, as a citizen, you do not have the sway with the elected officials there. The mayor, I can't vote in his election, so this Commission becomes the voice that I can come to. You are the ones that represent me in the issues that concern me. And I have a grave concern with what is going on with the water in Caddo Lake. Currently, I've been without water for days because of how that water system in Blanchard is handled. If we look at the time that I spent living in Shreveport and the two and a half years I've lived in Blanchard, I have been without water more frequently in that two and a half years than I have in the previous 40 years I lived in Shreveport. This becomes a problem for your citizens. We need you to be aware that what happens to those of us who do not have a voice through the mayor or other elected officials, you are our voice and we need you. I'm very disappointed that Mr. Kracman's motion was not acted on, didn't even come to a vote. So, we don't know where you stand. So, I don't know where I stand when it comes to how I interact with you in the future. I appreciate your effort, Mr. Kracman. I'm not in your district, but I appreciate your effort on my behalf. Thank you.

Jon Glover came before the Commission and gave the following comment

Good evening, Jon Glover, 9100 Walker Road, Apartment 217, Shreveport, Louisiana 71118. When I last stood before you all, I asked you all to provide us an explanation on every piece of legislation that could seemingly impact our lives regardless of where we live. Today, I did not meet such. I listened on my way here to see what was being shared with regards to where I was and I got here right when you all were speaking to Dr. Jones and appreciated the conversation, the comments that he had to share with you all because there have been inquiries as to how his process actually benefits us here in Caddo Parish. But I read over the agendas and when I looked at the agenda whereby water was an issue or could potentially be an issue, Resolution 8 of 2026. I did some homework yesterday afternoon, and I

sent an email to the Department of Conservation and Energy to provide to me those permitted users who use water out of Caddo Lake. Now it will take them some time to get in touch with me, I thought, until I received a call this morning and I spoke with Mr. James Devitt, who told me he was a part of the legal department for the Conservation and Energy Department. Now I understand what moratorium means. It means that there is something going on that we can solidify that you can vote on to say yay or nay. Now with that permitted users list we will know who those users are and where you all did not find it needed nor necessary to address it. I think you should have, even with just saying "We don't support," and then having a conversation helping us to understand and gain an understanding of what your positions were. You did not afford us with that and that is what I had asked you all in my last time I was here. Help us to appreciate what you all put before us. Legislation is important enough for you all to put it on the agenda. Then give us the courtesy of understanding what it is that you all will address. I thank you too for your time and God bless you.

COMMUNIQUES & COMMITTEE REPORTS

- Mr. Thomas addressed the audience and stated the Commission shares concerns about Caddo Lake and parish waterways, noting: the Parish has processes in place to handle and discuss water-related issues. The Commission intends to elevate these matters and address them in the proper forum and context. Mr. Thomas referenced a recent meeting with Congressman Johnson's office, during which parish waterways and dredging Caddo Lake were discussed. He also emphasized the Commission would not advance "contentious" items lacking merit, but reiterated the intent is to address the water issue appropriately and did not want citizens to leave feeling unheard or defeated.
- Mr. Atkins thanked the Presiding Officer for summarizing the Commission's position and stated the comments reflected his view. He said the moratorium felt premature, noting the issue should first be addressed by the Red River Compact Commission and the appropriate state agencies. He also said that no formal project had been announced and key details were unknown. While protection of Caddo Lake is important, he could not support a moratorium without more information.
- Mr. J. Young stated he had been at Caddo Lake recently and observed public concern (referencing signs). He supported protecting the lake but cautioned against broadly discouraging business without information. Mr. J. Young suggested moving the discussion into a committee setting—specifically mentioning the Rural Development Committee—to gather facts and discuss solutions that balance economic development with ecosystem protection.
- Mr. Kracman strongly objected to the lack of action and argued that the resolution did not reference Blanchard utilities and did not explicitly reference data centers. A moratorium would simply provide time for relevant bodies to conduct necessary discussions and a study to determine how much withdrawal the lake can withstand, he said. Mr. Kracman said that existing studies were described as old (referencing decades), and he stated the parish lacks a current study. He framed the resolution as proactive, aimed at getting ahead of potential impacts before decisions are finalized elsewhere. He stated commissioners could make a motion to reconsider at any time and requested a substantive conversation, emphasizing the intent was "pro Caddo Lake."
- Mr. G. Young referenced personal experience with water service issues through Blanchard utilities, indicating neighborhood impacts and a belief that the parish must do better.
- Mrs. Blake responded that declining to enact a moratorium was not "unintelligent," and stated she would not support a resolution without more information about the process and what exactly is being addressed. She referenced participation in discussions in Washington, D.C., stating there were important conversations about protecting parish waterways. She said she would not vote to stop something without knowing what is being solved.
- Mr. Burrell stated, as a point of information, that a water study could be pursued without adopting a moratorium, and questioned why a restriction would be put in place to accomplish something that could already be done through other means.

At this time, the Commission Convened into Executive Session to discuss 1st JDC Docket No. 659,061. Attorney Frazier advised that the Commissioners, Administrator, Assistant Administrator, Parish Attorney and Assistant Parish Attorney are to be part of the discussion. The Chambers was then cleared, and the Commission convened into Executive Session.

CONSENT AGENDA

- *Resolution No. 6 of 2026, a resolution amending the Rules & By-Laws of the Caddo Parish Commission regarding Standing Committees and otherwise providing with respect thereto*
