Resolution No. 52 of 2026 A RESOLUTION TO AUTHORIZE THE CADDO PARISH ADMINISTRATOR TO APPROVE THE ASSIGNMENT, BILL OF SALE AND CONVEYANCE OF STATE AGENCY LEASES NO. 20126, NO. 20381, AND NO. 22023 FROM SILVER HILL HAYNESVILLE E&P, LLC, SILVER HILL IV HAYNESVILLE E&P, LLC, SILVER HILL III BLM HOLDINGS, INC., LARKSPUR ROYALTIES, LP, AND SILVER HILL ENERGY OPERATING, LLC, TO WNR HAYNESVILLE OPERATING, LLC, AND OTHERWISE PROVIDING WITH RESPECT THERETO

BACKGROUND INFORMATION	
The Parish of Caddo is a Lessor in the following oil, gas and mineral leases, the Caddo Parish Commission to Merit Energy Services, LLC, in State Agency Lease #20126, dated August 12, 2009, and recorded at Registry No. 2248625, the Caddo Parish Commission to Classic Petroleum, Inc., in State Agency Lease #20381, dated July 14, 2010, and recorded at Registry No. 2305213, and the Caddo Parish Commission to Pine Wave Energy Partners Operating, LLC, in State Agency Lease #22023, dated May 12, 2021, and recorded at Registry No. 2838343. The Parish of Caddo has received a written request from Silver Hill Haynesville E&P, LLC, Silver Hill IV Haynesville E&P, LLC, Silver Hill III BLM Holdings, Inc., Larkspur Royalties, LP, and Silver Hill Energy Operating, LLC, collectively Sellers, seeking approval from the Parish of Caddo of an assignment, bill of sale and conveyance of State Agency Leases No. 20126, No. 20381, and No. 22023, from Sellers to WNR Haynesville Operating, LLC. Leases are located in Districts 1, 2, 7, 11 & 12. (Maps Attached)	
FINANCIAL IMPACT AND SOURCE OF FUNDING	
There is no cost to the Parish. Parish could receive future royalty payments from WNR Haynesville Operating, LLC.
